An Act to effect ~~adaptions~~ to certain laws.

A.D. 1972 Enacted by the Parliament of Guyana :—

- Short title. 1. This Act may be cited as the Adaptation of Laws Act 1972.
- Amendment of enactments, Schedule. 2. The enactments specified in the first column of the schedule shall be amended to the extent set out in the second column thereof.
- Construction of certain designations. 3. Wherever in any law made under the provisions of any enactment mentioned in the schedule or in any instrument or document of any kind issued under such law or enactment there are references to any designation or expression which has been altered by virtue of section 2, such references shall after the coming into operation of this Act be construed as references to the designation or expression as so altered.
- Conferment of existing functions and powers. 4. Any function, privilege, right, immunity or obligation conferred or imposed by any law immediately prior to the coming into operation of this Act upon the Commissioner of Lands and Mines in relation to the matters of mining and State forests shall, save as may otherwise be provided by the Forests Ordinance, be deemed to be conferred or imposed upon the Commissioner of Geological Surveys and Mines.
- Cap. 240. 5. Anything lawfully done in pursuance of any written law prior to its variation by virtue of the foregoing provisions of this Act and which would continue to have effect but for such variation, shall, unless the contrary intention appears, continue to have effect as if so done in conformity with the said law as in operation pursuant to such variation.

2. The Lands Department of the Ministry responsible for Agriculture (hereinafter referred to as "the department") which shall be deemed to be the successor of the department hitherto known as the Lands and Mines Department, shall consist of the Commissioner of Lands (hereinafter referred to as "the Commissioner") the Superintendent of Lands, the Cartographer, and such surveyors and other officers as may be requisite for the purposes of this Ordinance."

Section 5

Delete and substitute the following section —

"Charge
of State
Lands.

5. The department shall have the charge of, and act as guardian over all state lands, rivers and creeks of Guyana, except as comprised within a state forest declared under the Forests Ordinance."

Section 17

Delete and substitute the following section —

"17. Any reference to the Lands and Mines Department or the Commissioner of Lands and Mines in any written law, instrument or document of any kind subsisting or in force at the coming into operation of this section, shall, after the coming into operation of this section be construed and have effect as a reference to the department or the Commissioner, respectively."

Delete the words “and Mines” wherever they appear.

7. The Housing Ordinance 182. Delete the words "and Mines" wherever they appear.

- Section 2
- (a) Substitute for the definition of the expression "Commissioner" the following definition —
- ' "Commissioner" means the Commissioner of Geological Surveys and Mines; ' ;
- (b) substitute the words "Department of Geological Surveys and Mines" for the words "department of lands and mines."; and
- (c) substitute for the definition of the word "warden" the following definition —
- ' "mines officer" means any officer appointed for the purposes of this Ordinance and of the mining regulations to be in charge of a mining district. ' ;


