ORDINANCE No. 28 OF 1949.

AN ORDINANCE to allow and confirm certain additional expenditure incurred in the year ended the thirty-first day of December, 1948. AD. 1949

WHEREAS expenditure was necessarily incurred during the year ended on the thirty-first day of December, one thousand nine hundred and forty-eight on certain services approved by the Legislative Council on Supplementary Estimate but not provided for by the Appropriation Ordinance, 1948. No. 11 of
