## BRITISH GUIANA.

ORDINANCE NO. 54 OF 1955.

AN ORDINANCE to allow and confirm certain additional expenditure incurred in the year ended the thirty-first day of December, 1954.

WHEREAS expenditure was necessarily incurred during the year ended on the thirty-first day of December, one thousand nine hundred and fifty-four, on certain services set forth in the Schedule to this Ordinance but not provided for by the Appropriation Ordinance, 1954, or other Law.

BE IT, THEREFORE, ENACTED by the Legislature of British Guiana:—

1. This Ordinance may be cited as the Supplementary Appropriation (1954) Ordinance, 1955.

2. The expenditure during the year ended on the thirty-first day of December, one thousand nine hundred and fifty-four, to the amount of three million six hundred and thirty-five thousand nine hundred and fifty-eight dollars and eighty-seven cents on certain services set forth in the schedule to this Ordinance and not
