Section

1. Short title.
2. Supplementary amount authorised for financial year 1955.

AN ORDINANCE to allow and confirm certain additional expenditure incurred in the year ended the thirty-first day of December, 1955.

ENACTED by the Legislature of British Guiana:—

A.D. 1956

1. This Ordinance may be cited as the Supplementary Appropriation (1955) Ordinance, 1956. Short title.

2. The expenditure during the year ended on the thirty-first day of December, one thousand nine hundred and fifty-five, to the amount of four million eight hundred and eighty-two thousand four hundred and ninety-four dollars and forty-four cents on certain services set forth in the schedule to this Ordinance and Supplementary amount authorised for financial year 1955.
