## BRITISH GUIANA

ORDINANCE NO. 21 OF 1933.

AN ORDINANCE to extend the operation of and to amend the Rice (Export Trade) Ordinance, 1932. A.D. 1932.

**W**HEREAS the operation of the Rice (Export Trade) Ordinance, 1932, was extended to the thirty-first day of August, nineteen hundred and thirty-three;

And Whereas it is expedient further to extend the operation of and to amend the said Ordinance:

Be it, therefore, enacted by the Governor of British Guiana, with the advice and consent of the Legislative Council thereof, as follows:—



- Short Title. 1. This Ordinance may be cited as the Rice (Export Trade) Ordinance (No. 2), 1933, and shall be construed with the Rice (Export Trade) Ordinance, 1932, hereinafter referred to as the Principal Ordinance.

- Ordinance 47 of 1932 continued to September, 1934. 2. The Principal Ordinance shall continue in force until and including the thirtieth day of September, nineteen hundred and thirty-four.
- Amendment of sec. 3 of Ord. No. 47 of 1932. 3. Section three of the Principal Ordinance is amended—
- (i) by the substitution of the following for sub-section (2)—
- “(2) The Board shall consist of the following members—
- (a) the Manager of Barclays Bank (Dominion, Colonial and Overseas), and the Manager of the Royal Bank of Canada,
- (b) two officers in the public service appointed by the Governor, and
- (c) three other persons appointed by the Governor”;
- (ii) by the deletion of sub-sections (3) and (6), paragraph (b) of sub-section (7), all the words after “Secretary” in sub-section (8) and sub-section (9).
- New section added. 4. The following section shall be inserted after section five of the Principal Ordinance—
- “5 A. (1) The Governor in Council shall appoint an Advisory Committee whose duty shall be to advise the Board on the price of rice.
- (2) The committee shall consist of five persons chosen by the Governor in Council from a panel submitted by the Rice Association.
- (3) Three members shall constitute a quorum of the Committee.
- (4) Members shall hold office at the pleasure of the Governor in Council. A vacancy shall be filled in the manner provided in sub-section (2).”
- Establishment of advisory committee.
- Amdts. to Ord. No. 47 of 1932. Suspension of exporters' licences. 5. The Principal Ordinance is hereby amended as follows—
- (a) in paragraph (c) of section six by inserting the words “suspend or” before the word “revoke”;
- (b) in section nine by inserting the word “suspended” after the word “issued”;
- (c) in sub-section (1) of section eleven by inserting the words “suspended or” before the word “revoked.”
- (d) by repealing section fifteen.

6. The following shall be added at the end of section fourteen of the Principal Ordinance—

No. 47 of 1932

“Where any allowance is made to a purchaser by the agent of an exporter of any part of the commission or other remuneration paid to the agent by the exporter the sale in respect of which such allowance is made shall be deemed to be a sale at a lower price than that fixed by the Board within the meaning of this section.”


7. The Board shall in the months of January and July nineteen hundred and thirty-four transmit to the Colonial Secretary a report of its transactions to the thirty-first day of December nineteen hundred and thirty-three and the thirtieth day of June nineteen hundred and thirty-four together with a full statement of its accounts and expenditure. The reports shall be laid before the Legislative Council and published in the *Gazette*.

Board to transmit report of transactions to Colonial Secretary to be laid before Legislative Council.

8. The provisions of the Justices Protection Ordinance shall apply for the protection of all persons for anything done in execution of the Principal Ordinance.
