### ORDINANCE NO. 4 OF 1928.

A.D. 1928.

AN ORDINANCE to amend the Petty Debts Recovery Ordinance, 1893, with regard to the payment out of the Treasury of suitors' moneys.

[21st April, 1928.]

BE it enacted by the Governor of British Guiana, with the advice and consent of the Court of Policy thereof, as follows:—

Short Title.

No. 11 of 1893.

Amd. of sec. 55 (2) of Ord. 11 of 1893.

1. This Ordinance may be cited as the Petty Debts Recovery Ordinance, 1928, and shall be construed with the Petty Debts Recovery Ordinance, 1893, (hereinafter referred to as the Principal Ordinance) and any amending Ordinance.

2. Sub-section (2) of section fifty-five of the Principal Ordinance is hereby amended by deleting the words "by a written order of the Governor, on the representation of a Magistrate" at the end thereof and substituting therefor the words "on the written order of a Magistrate."

### ORDINANCE NO. 5 OF 1928.

A.D. 1928.

AN ORDINANCE to make provision as to the mode of calculation of the pension of Peter Moses de Weever.

[21st April, 1928.]

WHEREAS by Resolution No. LIX passed on the fourth day of November, 1927, by the Combined Court it was resolved that in view of the long and excellent service of Peter Moses

deWeever, formerly Schoolmaster at the Industrial School, Onderneeming, a period of five years and four months should be added to his service for the purpose of computing his pension ;

And whereas it is desirable to make provision for carrying the said Resolution into effect :

Be it, therefore, enacted by the Governor of British Guiana, with the advice and consent of the Court of Policy thereof, as follows :—

1. This Ordinance may be cited as the P. M. de Weever Pension Ordinance, 1928. Short Title.

2. Notwithstanding anything to the contrary in any Pension Ordinance, the pension of Peter Moses de Weever, formerly Schoolmaster at the Industrial School, Onderneeming, shall be calculated as though he had served for a period of thirty-five years in all. Pension to be calculated as though he served thirty-five years.

## ORDINANCE NO. 6 OF 1928.

AN ORDINANCE to amend the Evidence Ordinance, 1893, with respect to the use of reports of official analyses. A.D. 1928.

[21st April, 1928.]

BE it enacted by the Governor of British Guiana, with the advice and consent of the Court of Policy thereof, as follows :—

1. This Ordinance may be cited as the Evidence Ordinance, 1928, and shall be construed with the Evidence Ordinance, 1893, hereinafter referred to as the Principal Ordinance. Short Title.

2. In section forty-four of the Principal Ordinance the expression "Government Analyst" shall be construed to include an Assistant Analyst and the Government Bacteriologist. Amendment of sec. 44 (1) of Ord. 20 of 1893.

3. The Government Analyst (extension of meaning) Ordinance, 1920, is hereby repealed. Repeal of Ord. 21 of 1920.
