Short title. Cap. 82:21

Amendment of section 50 of the

Principal Act.

1. This Act, which amends the Intoxicating Liquor Licensing Act, may be cited as the Intoxicating Liquor Licensing (Amendment) Act 2010.

2. Section 50(4) of the Principal Act is amended by substituting for the words "one thousand" and "three thousand" the words "five hundred thousand" and "one million", respectively and by inserting the following words immediately after the end of the subsection (before the full stop) the following words "and in the case of a third offence, to a fine of one million dollars and to revocation of the licence".
