Enacted by the Parliament of Guyana:

Short title. Cap. 82:23

1. This Act, which amends the Bitters and Cordials Act may be cited as the Bitters and Cordials (Amendment) Act 1992.

Amendment of section 3 of the Principal Act.

2. Section 3 (5) of the Principal Act is hereby amended by the substitution for the words "three hundred dollars" of the words "three thousand dollars".

Amendment of section 7 of the Principal Act.

3. Section 7 (1) of the Principal Act is hereby amended by the substitution for the words "one hundred and fifty dollars" of the words "one thousand dollars".

Amendment of section 8 of the Principal Act.

4. Section 8 of the Principal Act is hereby amended by the substitution for the words "one thousand five hundred dollars" of the words "fifteen thousand dollars".

Amendment of section 9 of the Principal Act.

5. Section 9 (b) of the Principal Act is hereby amended by the substitution for the words "one thousand five hundred dollars" of the words "fifteen thousand dollars".

Amendment of section 16 of the Principal Act.

6. Section 16 (3) of the Principal Act is hereby amended by the substitution for the words "one hundred and fifty dollars" of the words "one thousand dollars".

Amendment of section 18 of the Principal Act.

7. Section 18 of the Principal Act is hereby amended by the substitution for the words "one thousand five hundred dollars" of the words "fifteen thousand dollars".

Amendment of section 19 of the Principal Act. 8. Section 19 (2) of the Principal Act is hereby amended by the substitution for the words "one thousand five hundred dollars" and "three hundred dollars" of the words "fifteen thousand dollars" and "three thousand dollars", respectively.
