AN ACT to amend the Town and Country Planning Act.

Enacted by the Parliament of Guyana:--

Short title. Cap, 20:01 1. This Act, which amends the Town and Country Planning Act, may be cited as the Town and Country Planning (Amendment) Act 1996.

2. Section 13 (2) of the Principal Act is hereby amended by the substitution for the words "two hundred dollars" of the words "twenty-five thousand dollars".

4. Section 15 (7) of the Principal Act is hereby amended by the substitution for the words "five hundred dollars" and "fifty dollars" of the words "sixty thousand dollars or to imprisonment for three months" and "five thousand dollars", respectively.

Amendment of section 22 of the Principal Act. 5. Section 22 (8) of the Principal Act is hereby amended by the substitution for the words "two hundred dollars" of the words "twenty-five thousand dollars or to imprisonment for three months".

Amendment 28 of the of section Principal Act. 6. Section 28 (2) of the Principal Act is hereby amended by the substitution for the words "two hundred dollars" of the words "twenty-five thousand dollars or to imprisonment for three months".

Amendment of section 29 of the Principal Act. 7. Section 29 of the Principal Act is hereby amended by the substitution for the words "five hundred dollars" and "fifty dollars" of the words "sixty thousand dollars or to imprisonment for three months" and "five thousand dollars", respectively.
