A. D. 1997 Enacted by the Parliament of Guyana:—

Short title.
Cap. 51:02

1. This Act, which amends the Motor Vehicles and Road Traffic Act, may be cited as the Motor Vehicles and Road Traffic (Amendment) Act 1997.
