For "five thousand dollars" substitute "not less than five thousand dollars nor more than ten thousand dollars", for "ten thousand dollars" substitute "not less than ten thousand dollars nor more than twenty thousand dollars" and for "three months" substitute "six months".

For "twenty-five thousand dollars" wherever those words occur substitute "fifty thousand dollars".
