A BILL

Intituled

AN ACT to incorporate the Board of Trustees of the Universal Church of Scientific Truth in Guyana and for purposes connected therewith.

Enacted by the Parliament of Guyana:—

A.D. 1975

- 1. This Act may be cited as the Universal Church of Short title. Scientific Truth (Incorporation of Trustees) Act 1975.
 - 2. In this Act, unless the context otherwise requires—interpretation
 - "the Board of Trustees" or "the Board" means the Board of Trustees of the Universal Church of Scientific Truth in Guyana incorporated by this Act:
 - "the Church" means the Universal Church of Scientific Truth in Guyana;
 - "Head of the Church" means the person holding the office of Head of the Church;
 - "member" means a member of the Board of Trustees.
- 3. The Reverend Doctor Walter Sydney Bayley, Head Incorporation of the Church, Sister Doris Franklin, Secretary of the Church, of Trustees. Brother Vibert Blackman, Treasurer of the Church, together with Brother Simon Prescott and Sister Mavis Soloman members of the Church, and their successors in office holding office in that behalf on the Board by virtue of the rules and practices of the Church, shall be a body corporate and shall have the name of the Board of Trustees of the Universal Church of Scientific Truth in Guyana.
- 4. There shall not be at any time more than five Death or Trustees of the Board and in the event of the death or absence from Guyana or inability or refusal of any one or more of the of member Trustees to act as such all or any of the powers conferred by of Trustees. this Act on the Board of Trustees may be exercised by the surviving or remaining Trustees being not less than three in number.

Vesting of property. schedule

6. The property described in the schedule is, without further assurance, hereby vested in the Board.

Gifts of property to to be the property of the Board.

7. All property of whatsoever nature or kind hereafter bequeathed by will or otherwise given t_0 the Church shall be deemed to be the property of the Board.

Tenure of property for B. All property vested in or hereafter acquired by the use and the Board shall be held by the Board for the use and benefit the Church. Of the Church.

Evidence of membership of Board.

9. A statement that any person named therein has been appointed a member of the Board of Trustees purporting to be signed by the Head of the Church or the Secretary or the Treasurer of the Church shall be prima facie evidence of the said fact.

Service of process.

All process which is required to be served on the Board shall be deemed to be sufficiently served if served at the residence in Guyana of any of the members of the Board and a copy thereof published in the Gazette.

Phang, Sworn Land Surveyor dated 25th March, 1954, and deposited in the Deeds Registry at Georgetown on the 20th day of May, 1954, the said lease executed on 20th day of May, 1954, No. 197 being transferred to the said Grace Bhagwantie Boodhoo on the 11th day of August, 1965 — No. 50, and also subject to a right of way in favour of the said lessees, their and each of their invitees, servants, agents and all others authorised by them or any of them over and along a strip of land 3 (three) feet wide and 94.4 (ninety-four decimal four) foot in length situate within the said half let and leading four) feet in length situate within the said half lot and leading to Hadfield Street, the said strip of land being shown marked "passage way" on the aforesaid plan by M. A. Phang, dated 25th March, 1954.

EXPLANATORY MEMORANDUM

This Bill seeks to provide for the incorporation of the Board of Trustees of the Universal Church of Scientific Truth in Guyana.
