AN ACT to sanction certain additional expenditure incurred in the year ended the thirty-first day of December, 1962.

Enacted by the Parliament of Guyana:—

1. This Act may be cited as the Supplementary Appropriation (1962) Act, 1968. Short Title.

2. The expenditure during the year ended on the thirty-first day of December, one thousand, nine hundred and sixty-two, to the amount of one million, five hundred and fourteen thousand, two hundred and seventy-seven dollars and ninety cents on certain services set forth in the schedule to this Act and not provided for, or not fully provided for, by the Appropriation Ordinance, 1962, is hereby sanctioned.
