ATKINSON AIRPORT (CHANGE OF NAM ) BILL, 1969.

A BILL

Intituled

An Act to effect changes in the names of Atkinson Airport and Atkinson Acrodrome and to amend Chapter 282.

Enacted by the Parliament of Guyana:-

A D. 1969.

- 1. This Act may be cited as the Atkinson Airport (Change of Short title. Name) Act, 1969.
  - 2.(1) Every law, instrument or document of ny kind having Changes in effect at 1st May, 1969, and which makes reference to the of Atkinson Atkinson Airport or the Atkinson Aerodr me shall, if it Airport and continues to have effect at the commence ent of this Act, Aerodrome be construed in relation to any time after 1st May, 1969, as if for every such reference to the said Atkinson Airport or Atkinson Aerodrome there had been substituted a reference to the Timehri International Airpo t or the Timehri Aerodrome, respectively.
    - (2) Notwithstanding the change of name eff ted by subsection (1) of this section, the alteration in the names of the Atkinson Airport and the Atkinson Aerodrome shall not projudice

or affect any rights accrued or obligations incurred or anything which remains to be done or foreborne to be done in relation to the Timehri International Airport or the Timehri Acrodrome under or by virtue of its previous name.

Amendment of Chapter 282.

- 3.(1) Section 3 of the Timehri International Airport Ordinance (hereinafter in this section referred to as the Principal Ordinance) is hereby amended in the following respects
  - (a) by the substitution of the words "Minister for the time being assigned responsibility for civil aviation" for the words "Governor in Council" in subsection (1) thereof; and
  - (b) by the addition thereto of the following subsection as subsection (3)
    - "(3) The power to make regulations conferred by this section shall include power to make regulations providing for the imposition and collection of charges for the admission of persons to such part of the Timehri International Airport as may be specified, and for the use of parking places for motor vehicles and aircraft at the said Airport."
  - (2) Anything lawfully done under the Principal Ordinance prior to its amendment by paragraph (a) of subsection (1) of this section, and which would continue to have effect but for such amendment, shall continue to have effect as if so done in conformity with such amendment.

#### EXPLANATORY MEMORANDUM

This Bill seeks to make provision for the redesignation of the Atkinson Airport and Atkinson Aerodrome as the Timehri International Airport and the Timehri Aerodrome, respectively. Provision is made in clause 3 of the Bill to enable charges to be imposed for the admission of persons to any specified part of the Airport or for the parking of vehicles at the Airport.
