Intituled

AN ORDINANCE to allow and confirm certain additional expenditure incurred in the year ended the thirty-first day of December, 1961.

Enacted by the Legislature of British Guiana :—

1. This Ordinance may be cited as the Supplementary Appropriation (1961) Ordinance, 1965. Short title.

2.
