## GEORGETOWN CULTURAL CENTRE (AMENDMENT) BILL, 1964.

Arrangement of Sections.

### Section

1. Short title.
2. Amendment of section 5 of Chapter 204.
3. Insertion of section 5A in Chapter 204.

### A BILL

Intituled

An Ordinance to amend the Georgetown Cultural Centre Ordinance.

Enacted by the Legislature of British Guiana:—

A.D. 1964.

1. This Ordinance may be cited as the Georgetown Cultural Centre (Amendment) Ordinance, 1964, and shall be construed and read as one with the Georgetown Cultural Centre Ordinance, hereinafter referred to as the Principal Ordinance, and any Ordinance amending the same. Cap. 204

2. Section 5 of the Principal Ordinance is hereby amended: Amendment of section 5 of Chapter 204.
- (a) by the repeal of subsection (2) thereof;
  - (b) by the renumbering of subsections (3) and (4) as subsections (2) and (3) respectively; and
  - (c) by the substitution for the renumbered subsection (3) of the following subsection—  
“(3) The Board may for such purposes as it may deem fit dispose of the eastern portion of the parcel of land on the plan specified in the description of the area aforesaid.”

3. The Principal Ordinance is hereby amended by the insertion immediately after section 5 of the following section— Insertion of section 5A of Chapter 204.

“Erection of buildings on eastern portion.”  
5A. Where it is necessary so to do for the purposes for which the Board may dispose of the parcel of land in pursuance of subsection (3) of section 5 of this Ordinance, buildings may be erected thereon to give effect to such purposes, notwithstanding anything to the contrary contained in any other Ordinance.”

### OBJECTS AND REASONS

This Bill seeks to amend the Georgetown Cultural Centre Ordinance, Chapter 204, to permit the eastern portion of the area described in the schedule to that Ordinance to be disposed of and to permit its use for purposes other than cultural. It also seeks to provide that buildings may be erected on the land.
