CASE PENSION BILL, 1964.

A BILL

Intituled

An Ordinance to make special provision with respect to the pensionable service of Frederick Walter Eleazar Case.

Enacted by the Legislature of British Guiana:—

A.D. 1964.

1. This Ordinance may be cited as the Case Pension Ordinance, 1964. Short title.

“the Principal Ordinance” means the Pensions (Consolidation) Ordinance, 1957.
3. Anything in the Principal Ordinance to the contrary notwithstanding, the service of Frederick Walter Eleazar Case between the period commencing on the 27th October, 1948, and ending on the 31st July, 1951, both dates inclusive, shall be deemed to be pensionable service for the purposes of the Principal Ordinance. OBJECTS AND REASONS

Mr. F. W. E. Case was seconded from his post as Senior Assistant Master on the staff of the Government Training College to the post of Resident Tutor in the Extra Mural Department of the former University College of The West Indies with effect from the 1st August, 1948 to the 31st July, 1951.

2. Mr. J. A. Rodway was appointed Senior Assistant Master on the staff of the Government Training College *vice* Mr. Case with effect from the 27th October, 1948. As a result of Mr. Rodway's appointment Mr. Case could not be regarded as holding an office in the public service of British Guiana, although contributions in respect of his pension continued to be received by the Government of British Guiana throughout the period during which Mr. Case was employed by the former University College of The West Indies. On his return to British Guiana at the end of the period of his secondment, Mr. Case was appointed to the office of Education Officer with effect from the 1st August, 1951.

3. The provisions of section 6 of the Pensions (Consolidation) Ordinance, 1957, (which provides for periods of service on secondment to be reckoned as pensionable service) do not apply since Mr. Case was not seconded to an office in the service of the colony of British Guiana within the meaning of that section. This Bill therefore seeks to provide for the period of Mr. Case's service with the former University College of The West Indies to be deemed to be pensionable service.
