"scheduled Government" means -

the Government of any territory, or any authority, mentioned in the schedule to these Regulations;

- the Government of Ceylon, in respect of any officer appointed to service under that Government before the 4th day of February, 1948;
- the Government of Palestine, in respect of any officer ap-(c) pointed to service under that Government before the 15th day of May, 1948;
- the Government of the Somali Republic in respect of any officer appointed to service under the Government of the Somaliland Protectorate before the 26th day of June, 1960;
- the Government of Cyprus, in respect of any officer appointed to service under that Government before the 16th day of August, 1960;
- the East African Common Services Organisation in respect of any person deemed to have been appointed to service as President, Vice-President, Justice of Appeal, Registrar, officer or servant of the Court of Appeal for Eastern Africa by or under the Eastern Africa Court of Appeal Order in Council, 1961; and

the Interim Commissioner for the West Indies in respect of (g) any person deemed to have been appointed or appointed to service as Judge, Registrar, officer or servant of the British Caribbean Court of Appeal by or under the British Caribbean Court of Appeal Order in Council, 1962:

Provided that the Governor may, by order, vary the schedule to these Regulations by the addition thereto or the removal therefrom of any Government or any authority.'

- 4. The list of scheduled Governments in the schedule to the Amendment of schedule to Regulations in the Principal Ordinance is hereby amended — the Regulations in the Principal Ordinance is hereby amended — the Principal (a) by the addition thereto of the authority "the Interval
 - by the addition thereto of the authority "the Interim Commissioner for the West Indies"; and
 - (b) by the deletion of the words "Cyprus" and "Somaliland".

OBJECTS AND REASONS

The purpose of this Bill is to safeguard the superannuation position of officers who have been transferred to or may in the future be transferred to or from the service of the Government of any country or territory which following independence ceases to be part of Her Majesty's dominions or under Her Majesty's protection, but remains in the Commonwealth. Service under any such Government must be determined as "public service" in order to preserve the officers' pension rights under the Pensions (Consolidation) Ordinance, 1957.

- 2. Clause 2 of the Bill therefore seeks to amend the definition of "public service" or "service" in that Ordinance to include service in any such independent territory.
- 3. Clause 3 of the Bill seeks to amend the definition of "scheduled Government" in regulation 2 of the Regulations in the schedule to the Ordinance.
