IN EXERCISE OF THE POWERS CONFERRED UPON THE RULES COMMITTEE UNDER SECTION 40 OF THE COURT OF APPEAL ACT, WE VICTOR EMANUEL CRANE, CHANCELLOR, KENNETH MONTAGUE GEORGE, CHIEF JUSTICE, RONALD HEWLEY LUCKHOO, JUSTICE OF APPEAL, RUDOLPH HALDANE HARPER, PUISNE JUDGE, OSLEN AINSWORTH FITZGERALD SMALL, REGISTRAR OF THE SUPREME COURT OF JUDICATURE AND DEREK CHUNILALL JAGAN, ATTORNEY-AT-LAW, BEING THE MEMBERS OF THE RULES COMMITTEE CONSTITUTED UNDER SECTION 67 OF THE HIGH COURT ACT, CAP. 3:02, DO HEREBY MAKE THE FOLLOWING RULES OF COURT: —

1. These Rules, which amend the Court of Appeal Rules\*, Citation. may be cited as the Court of Appeal (Amendment) Rules 1983.

2. Order 2 of the Principal Rules is hereby amended by the insertion immediately after rule 12 of the following rule as rule 12 A —

12A. After the preceding provisions of this Order have been complied with, the Registrar shall serve notice on the appellant and the respondent that the documents to be included in the record are ready and may be obtained."
