### Intituled

### AN ACT to amend the Spirits Act.

A. D. 1992 Enacted by the Parliament of Guyana :-

Short title. Cap. 82:24

1. This Act, which amends the Spirits Act, may be cited as the Spirits (Amendment) Act 1992.

2. Section 2 of the Principal Act is hereby amended as follows -

  - (b) any computation of the volume of any liquor or of the alcohol contained in any liquor shall be made in litres as at 20° celsius; and
  - (c) the alcoholic strength of any liquor is the ratio of the volume of the alcohol contained in the liquor to the volume of the liquor (inclusive of the alcohol contained in it)";
- (b) in subsection (1), as so renumbered —
- (b) (i) by the insertion after the words "In this Act—" of the following definition —

"alcohol" means ethyl alcohol';

- (ii) by the deletion of the definition of "gallon";
- (iii) by the insertion after the definition of "Government Analyst" of the following definition —
  - ""litre" means the litre as defined by any written law;
- (iv) by the deletion of the definition of "proof"; and
- (v) by the insertion after the definition of "still" of the following definition —

"strength" in relation to any liquor means its alcoholic strength computed in accordance with subsection 2, the ratio referred to in paragraph (c) thereto being expressed as a percentage"; Amendment of section 12 of the Principal Act.

#### EXPLANATORY MEMORANDUM

This Bill seeks to amend the Spirits Act, Cap. 82:24, to change the mode by which the strength of any liquor is determined so as to conform with the International Organisaion of Legal Metrology (OIML) system of Alcoholometry. As a result of the amendment sought to be made, all units of Imperial weights and measures pertaining to goods containing alcohol are changed to Metric Units.
