BY-LAWS

Made Under

THE MUNICIPAL AND DISTRICT COUNCILS ACT

(Cap. 28:01)

UNDER SECTIONS 303 AND 304 OF THE MUNICIPAL AND DISTRICT COUNCILS ACT, THE FOLLOWING BY-LAWS HAVE BEEN MADE BY THE PLAISANCE/INDUSTRY DISTRICT COUNCIL AND APPROVED BY THE MINISTER:—

1. These By-laws may be cited as the Plaisance/Industry District Council (Pound), (Reward and Poundage Money) By-laws 1990.

2. A pound is hereby established at North Slip Sparendam, East Coast, Demerara and shall be called the Plaisance/Industry District Council Pound.

Establishment of pound.

3. Where any animal specified in the first column of the Schedule strays on private property situated within the Council area of the Plaisance/Industry District Council, any owner or occupier of such property or any person authorised in writing by such owner or occupier, who detains and takes such animal to the Plaisance/Industry District Council Pound, shall receive from the pound-keeper thereof by way of reward, the sum set out in the second column of the Schedule in relation to the animal specified in the first column.

Stray animals. Schedule

4. The pound-keeper shall, before delivering an animal impounded in the Plaisance/Industry District Council Pound, demand and receive from the person claiming the animal —

- (a) the poundage money set out in the third column of the Schedule in relation to the animal specified in the first column; and
- (b) the sum for feeding the animal set out in the fourth column of the Schedule in relation to the animal specified in the first column.
