PROCLAMATION

By the President of the

Co-operative Republic of Guyana

PRESIDENT

WHEREAS by Proclamation dated 27th day of December 2019, issued under Article 70 (2) of the Constitution, the Eleventh Parliament of Guyana was dissolved on the 13th day of December, 2019, and General and Regional Elections held;

AND WHEREAS there was a prolonged and undue delay in the declaration of the results of those elections beyond and outside of my control which resulted in the declaration of the final results of those elections being made on the 2nd day of August 2020, and as a consequence thereof, there could have been no session of Parliament held within the timeframe prescribed in and by Article 69 (1) of the Constitution;

AND WHEREAS it is provided by Article 69 (1) of the Constitution that each session of Parliament shall be held at the place within Guyana and shall begin at the time, that the President shall appoint by Proclamation;

AND WHEREAS in view of the negative impact the Coronavirus (COVID-19) pandemic shall have on sittings in the Parliament Chamber, Public Buildings, Georgetown, due to the limited space available in the Chamber, it shall be unsafe to hold sittings in the Parliament Chamber;

NOW THEREFORE, in pursuance of the powers conferred upon me by Article 69 of the Constitution, I do hereby appoint as the place where a session of the Twelfth Parliament shall be held, the Arthur Chung Conference Centre, Liliendaal, Greater Georgetown, Guyana, or any other place a Member may choose to participate in the deliberations of the National Assembly remotely by electronic means, and 10 o'clock in the morning of the 1st day of September 2020 as the time when the session shall begin, and the named venue

shall so remain until notification is issued by the Speaker that the COVID-19 pandemic has been abated after which there shall be a resumption of the sittings in the Parliament Chamber, Public Buildings.

Prime Minister [Brigadier (Ret'd) Phillips]: Mr. Clerk, I propose Mr. Manzoor Nadir, no stranger to the National Assembly as a long-standing Member, to be the Speaker for the Twelfth Parliament.

The Clerk: Thank you, Sir. I need a seconder.

Minister of Parliamentary Affairs and Governance [Ms. Teixeira]: I would like to second the nomination of the Prime Minister to have Mr. Manzoor Nadir as the Speaker of the Twelfth Parliament.

The Clerk: Thank you, Ms. Teixeira. Are there any further nominations for the position of Speaker?

There being no further nominations, I therefore declare Mr. Manzoor Nadir duly elected Speaker of the National Assembly of the Twelfth Parliament of Guyana. I will invite Mr. Nadir to come forward and take the Oath.

The Clerk administered the Oath of Office to the Speaker.

The Clerk: Mr. Nadir, congratulations and best wishes. We cannot shake hands. The practice is that I invite the proposer and the seconder to escort Mr. Nadir. In light of Coronavirus disease (COVID-19), I will move away from the practice and I will escort Mr. Nadir to his Chair. I do not know whether I should continue the practice. Are there any objections?

Ms. Teixeira: We have no objections.

WHEREAS Standing Order 9 provides that "unless there are special reasons for so doing, no sitting of the National Assembly shall be held between the 10th August and 10th October in any year;

AND WHEREAS Standing Order 112 provides that any one or more of the Standing Orders may be suspended, after notice, or with the leave of the Speaker, on a motion by a member at any sitting;

AND WHEREAS due to the dissolution of the 11th Parliament on the 30th December, 2019, there has been no sittings of the National Assembly, and, therefore no Annual Budget has been presented and considered for the year 2020;

AND WHEREAS the Government of Guyana is desirous of commencing the work of the National Assembly as soon as possible including the urgent presentation and consideration of the Estimates of Revenue and Expenditure for the year 2020 in the National Assembly on or before 10th October, 2020;

BE IT RESOLVED:

"That the National Assembly agrees to suspend Standing Order No. 9 in order to allow the commencement of sittings of the National Assembly to deliberate on urgent parliamentary matters including presentation and consideration of the 2020 Estimates of Revenue and Expenditure on or before 10th October, 2020."

Ms. Teixeira: Mr. Speaker, the suspension of Standing Order No. 9 is with regard to us meeting during the period of recess, 10th August to 10th October of this year.

As, I think, the whole Assembly is aware that there was undue and a very prolonged and torturous delay of over five months before we could have had the declaration of the 2020 Elections. Therefore, we are forced to meet in a period that would normally be recess.

As you are aware, Mr. Speaker, there is no budget for the year 2020 and we are in the last quarter of the year. This is an urgent matter and I, therefore, ask that the House supports the motion in my name.

However, in light of COVID-19 measures and the urgency to conclude a lot of our work, we are proposing that sittings of the Twelfth Parliament commence and continue from 10.00 a.m. with breaks at 12.00 p.m., resuming the sitting at 1.00 p.m., another break at 4.00 p.m. and concluding the sitting at 8.00 p.m.

We believe that, particularly during budget, this will be required. I am advised by the Minister of Health, and it is stated in the COVID-19 measures of 31st August 2020, that Parliament is an essential service and, therefore, we can go pass the curfew to 8.00 p.m., if it is required.
