Question is proposed that the sum of \$75,000,000 for Agency 01 - Office of the President, Programme 011 - Administrative Services - Chart of Account 6321 -

The Chairman: The Honourable Member Mr Corbin. [Pause] I will give you half a minute to get yourselves in order. Financial paper No. 3, Mr Corbin and it is the first Item 1, Agency code 01-011., Office of the President, Administrative Services.

Mr Robert HO Corbin: I take it you are at first page Sir, item 1?

The Chiarman: Yes, first page, item 1.

Mr Robert HO Corbin: Yes, but Page 30 in the Estimates. I would like to, the Minister, to inform this House:

- whether this \$75,000,000 has already been spent, and
- what percentage of this \$75,000,000, if indeed it has been spent, went to the Joint Services? and
- what percentage went to the alleged informant, if indeed this is a specific reward that was paid for Fineman?

Those are my first set of questions on that item.

The Chairman: The Honourable Minister in the

NATIONAL ASSEMBLY DEBATE 30 OCTOBER 2008 Ministry of Finance.

Hon Jennifer I Webster: Mr. Chairman, the \$75,000,000 being requested now, \$25,000,000 of that amount represents meeting the rental shortfall of the IAST. IAST and EPA share common office facilities, and \$25,000,000 of that sum is meant to meet that expenditure.

As it relates to the question asked by the Honourable Leader of the Opposition, I wish to say that the sum of \$50,000,000 was publicly announced to meet expenditure related to intelligence gathering re Operation Restore Order; \$20,000,000 of that is meant to go to the Guyana Police Force; another \$20,000,000 to the Guyana Defence Force, and the remainder will be disbursed subject to approval by the Defence Board.

The Chairman: The Honorable Member Mr Robert Corbin.

Mr Robert HO Corbin: Supplementary again, Sir. I am not sure from what the Honourable Minister has said, this note specifically states, to cover IAST rent, shortfall from Environmental Protection Agency, but she has clarified that \$25,000,000 is going there. We already have \$669 million voted under this provision earlier in the year. So I am trying to find out from that \$75,000,000, it means indeed \$50,000,000 is left. So my question is what percentage of this amount is being

paid to the Agency then, now that she said 20 and 20 is 40; what percentage is going directly to the agency for their own use, and what percentage is going to the informant. Unless she is saying that this is not the money that is paying the reward for Fineman and this is for other rewards. Because it says payment of reward offered in fighting crime, and the only one that I know about, Sir, is the one that was publicly announced for Fineman. So am assuming that this is the supplementary provision sought. So all I need to know, I am not asking the name of the informant, I just want to know what percentage is going to the agency, and what percentage is being paid to the informant.

Hon Jennifer I Webster: I think, Mr. Chairman, I already said that the funds are going to be utilized for whistleblowers, informants, et cetera, and they will be disbursed accordingly as I stated earlier.

Mr Robert HO Corbin: So the Minister saying that this has nothing to do with the reward for Fineman, then?

Hon Jennifer I Webster: Well, Mr. Chairman, I did not make any mention of anyone.

Mr Robert HO Corbin: Is this a new head which is being created under the Office of the President under this head for payment to the security forces for paying whistleblowers, or this was a regular head, and if so, what was the previous amounts allocated for that purpose?

Hon Jennifer I Webster: Mr. Chairman, in our 2008 budget, we would have voted funding under this same sub-head of charge, for the Joint Intelligence Coordinating Centre and that sum is going to be disbursed through that head.

The Chairman: Mr. Norton.

Mr Aubrey C Norton: Mr. Chairman, could the Hon Minister tell this House, she said it was 20/20/10, what were the factors and the criteria utilized for that type of distribution?

Hon Jennifer I Webster: Mr. Speaker, in response to that question, I am unable to answer that at this present time.

Mr Aubrey Norton: Mr. Speaker, I think in the circumstances, you walk with your technical people, so you consult with them and they tell us.

The Chairman: Thank you, Honourable Members. Honourable Members, there is in an omission in our procedure, just to allow me to correct before I proceed to put the item.

The Hon Minister of Finance

Hon Dr. Ashni K Singh: Mr. Chairman, thank you very much. Mr. Chairman. In accordance with Article 171(2) of the Constitution, I signify that Cabinet has recommended for consideration by the Assembly the motion for the approval of the provisions set out in the financial paper No. 3 of 2008, supplementary, schedule of supplementary provisions, current and capital estimates totaling \$1,848,047,997 for the period from 23 July to 22 October 2008. And I now move the motion.

The Chairman: Thank you Honourable Members, the motion is proposed, and we should, we will consider the paper as usual, that is, items will be taken from both the capital and current estimates, in the order for which the Minister is responsible.

Honorable Members, we have completed Item 1 - Agency 01 - Programme 011. Allow me now to put that item, and then proceed to the next one. I have proposed the question ... You have not finished Mr. Norton?

Mr Aubrey C Norton: Mr Chariman, I wanted to ask a question on the rent.

The Chairman: On the ...?

Mr Aubrey C Norton: On the first part, the shortfall of the rent. I wanted to ask the Honorable Minister:

- If there's a contract between the two agencies, that are government agencies, and
- Iif there was a contract, why we didn't know how much we had to pay at the beginning of 2008, and if we didn't have it, so that we should know why we didn't

Hon Jennifer I Webster: Mr. Chairman, the two agencies, they have an arrangement in writing, whereby they share common office space, and in doing so, one agency is responsible for meeting the cost of all utilities, so the other agency pays based on a computation, rental to offset the electricity charges, et cetera, incurred by that agency, and it is reflected through a rental agreement.

Mr Aubrey C Norton: Mr. Chairman, I do not think the question was answered. You said to me that there is this agreement, but I am saying if there is this agreement, that this would have been known at the beginning when a budget was prepared for the year. Unless you are saying to me that there is a change in the amount. Why do we need to come to the National Assembly for this now? It is a valid question, it should be answered.

Hon Jennifer I Webster: Mr. Chairman, I think that the one agency, in projecting the revenue which should have met this expenditure, they had a revenue shortfall, NATIONAL ASSEMBLY DEBATE 30 OCTOBER 2008 and hence that is why we are coming to the House to request the additional funding.

Agency 01 - Office of the President, Programme 011 - Administrative Services Chart of Account 6321 - Subsidies and Contributions to Local Organisations - \$75,000,000 - agreed to and ordered to stand part of the Estimates.

# ITEM 2 - AGENCY 16 - MINISTRY OF AMERINDIAN AFFAIRS, PROGRAMME 161 -AMERINDIAN DEVELOPMENT - Chart of Account 6302

Question is proposed that the sum of \$7,762,000 of Agency 16 - Ministry of Amerindian Affairs, Programme 161 - Amerindian Development - Chart of Account 6302 - Training (Including Scholarships) - stands part of the Estimates

The Chairman: The Honourable Member Mr Corbin

Mr Robert HO Corbin: Permit me Sir, just to say that I should have spoken after the Minister of Finance, as originally planned, but since he did not present his paper, just to place on record, our presence here in this Parliament this afternoon under serious protest. Had it not been for the financial matters that are being discussed, we would have stayed away from this

Parliament this afternoon, because of the Government's breach of faith that this week we should have been meeting on Wednesday to deal with Members' business, and it is only because of the fact that billions of dollars are going to sneak through this Parliament, that we opted to be here. Yes, if we were not here, it would be sneaked through without question. That is the only reason why we are here, to question these finance, but we are meeting under serious protest for breach of faith, and failure to observe a decision of the Parliamentary Management Committee. And so I would like it to be recorded.

And so my second question, Sir, is on this amount of \$7,000,000 ... [Interruption]

The Chairman: Yes, Honourable Member.

Hon Samuel AA Hinds: Mr. Speaker, I understand that the Honourable Member maybe seeking to the issue of the last Order Paper on Monday, had three items listed on it, and as it turned out, we only had completed two. In the meanwhile, we had made arrangements for this meeting, with the expectation at the time, maybe it did not turn out to be reasonable perhaps, that we would have completed all three of those motions on Monday afternoon. I think that maybe we need to meet to discuss this matter some more, maybe at a special PMC meeting. We know, we have referred to the minutes of the meeting in which it

was stated on one part that a fourth meeting would be held on Wednesday, but further down, there was a provision, and as it was, it was raised by, there was a suggestion if not a provision, and as it was, there was a suggestion the if not a provision which was raised by the Honourable Member Mr. Murray that there would be some considerations about enough business being there to hold the meeting. But I do not know that this may be the time and place convenient to really discuss this matter, and maybe we could consider a special PMC meeting to review this matter.

Mr Aubrey C Norton: Mr. Chairman, I think we should clarify it

The Chairman: Mr Corbin, are you proceeding or you want to say something further, because I want to clarify it here and now?

Mr Robert HO Corbin: No, I just want to say your Honour, that on the last occasion, I said nothing; I did not make any fuss in this House. I think you gave proper guidance And I would have thought that the Government recognizing that they were in breach of that agreement, having failed to communicate with us, would have utilized the gap between that suspension of the House and this sitting, to even attempt to rectify and explain, at least to the People's National Congress Reform these matters, but we have been treated with the usual scant discourtesy, in this same way the Prime

Minister, at the last he just decided that well, we are going ahead anyway. So that is why I wanted to place on record, there has been absolutely no communication or explanation to the opposition parties, even if it was an emergency. And it is the kind the discourtesy that I am referring to even after you drew it to their attention.

The Chairman: Thank you Honourable Members

Honourable Members, we still have the Item 2, Agency 16 - Programme 161.

Mr Robert HO Corbin: Yes on item 2, now Sir. The original amount was \$62 million, and now we are asking for supplementary provision for \$7 million. I am not necessarily objecting to it, because I do not know the extent of it, and perhaps the original sum was not properly calculated. But it is mentioned to make expenditure for Guardians that could probably be; I do not know, is it because of the steep rise in the cost of living, but they have dorms, uniforms, pocket allowances for the hinterland students, programme based on an increased rate, so I would like to know from the Minister, first of all, how many students are going to benefit from this programme. I have a few more questions, but it may be clarified if I hear how many students.

The Chairman: The Honourable Minister of Amerindian Affairs.

Hon Pauline R Sukhai: Mr. Chairman, the question was how many students would benefit from this increase; it would be 295 hinterland scholarship students.

Mr Robert HO Corbin: Thank you. Would the Honourable Minister be in a position to inform the House what percentage of increase in rates have been approved, and in what areas, so that we can be sure that these students are adequately taken care of because of the rising cost of living?

Hon Pauline R Sukhai: Mr. Chairman, the opposition's question is very relevant. It was the rising cost of living in our country, and the increases were for the guardians. The guardians moved from \$12,000 to \$16,000 and that was the percentage of thirty-three.. The students who reside in the dorms, they had an increase of twenty-nine percent that is from \$3,500 per month to \$4,500. For the uniform allowances, each student who received \$7,000 in the past will now receive \$10,000 which is a forty-three percent increase, and a pocket allowances which was \$2,600 is now going to be \$4,000, and it is an increase of fifty-four percent...

The Chairman: The Honourable Minister of Labour.

Hon Manzoor Nadir: Could I get the supplementary to the Minister, please? Could the Minister say to us

Hon Pauline R Sukhai: To appreciate what is happening, is that since 2006 there has been no increase? The increases will take effect from August and will last until December.

Question is proposed that the sum of \$600,000,000 for Agency 21 - Ministry of Agriculture, Programme 212 - Crops and livestock and Support Services - Chart of Account 6321 - Subsidies and Contributions to Local Organisations - stands part of the Estimates.

The Chairman: The Honouarble Member Mr Robert Corbin.

Mr Robert HO Corbin: Yes, your Honour. The

original sum voted was \$524,000,000 and there was a \$31,000,000 sought in previous supplementary provisions. Now this supplementary provision to facilitate the bulk purchase and resale of fertilizer to combat rising food prices is \$600,000,000. question to the Minister, if this is to facilitate the bulk purchase and resale of fertilizers, is there some revolving fund, I would like some clarity on this because this is treated here in Current Estimates. as though it is expenditure. So I would like some clarification about how this money is treated, because if \$524,000,000 were approved then, and it is being used for purchase in bulk and resale, then that money should be there somewhere either in stock or cash. unless there is some other explanation. Is it that the capital now must move into a billion? I need some clarity.

The Chairman: The Honourable Minister of Agriculture

Hon Robert M Persaud: Thank you very much, Mr. Chairman. The intention behind this measure was to provide our farmers with access to fertilizer at an affordable price. Because earlier this year, and late last year, when we saw the steep rise in fuel, and because fertilizer is considered part of the petrochemical industry, fertilizer prices went up as much as sixty percent, and we saw that the increased acquisition

# NATIONAL ASSEMBLY DEBATE 30 OCTOBER 2008 costs was -

- (i) was causing a supply constraint on the local market; and
- (ii) with the increased costs, was also creating some uncertainty in terms of our farmers' ability to able to procure the fertilizer.

And the Government, as part of a comprehensive menu of measures in terms of responding to what we saw globally taking place, and to cushion those effects on the local economy, advanced through this mechanism, and that is what we sought here, the sum of \$600,000,000 to the Guyana Marketing Corporation., which will then engage a supplier and to have the fertilizer brought here in a huge quantity, 12,500 tonnes, so that it can be sold to the farmers at a minimal markup, even zero markup, just recovering the cost. And that sum, once it is recovered, will then be returned or reimbursed to the Contingency Fund. This is intended to be a temporary assistance to the farming community, and those of us who might be looking in terms of tracking of what is taking place; in terms of advertisement and tenders would see that there is currently an advertisement out, and we are inviting a supplier to bring to Guyana or to supply to the New GMC, 12,500 tonnes of fertilizer, that would be going to the rice crop and also the sugar industry.

Let me also add, the advantage in going in terms of the bulk fertilizer, in that when many of the importers currently bring into the country about 3,000 tonnes, but if we are able to procure 12,500 tonnes, we would get the further reduction. This is all part of our effort, the Government's effort, of looking and ensuring that our farmers get the best deal, and the general population is cushioned from the impact of the increased cost of inputs. [Applause]

Mr Robert HO Corbin: Supplementary, Sir.

The Chairman: Mr Robert Corbin.

Mr Robert HO Corbin: I thank the Minister for this extensive bit of information, but my question really, still stands. You said that this money will be handed back? May I ask the Honourable Minister whether this fertilizer is for the farmers for this year, or next year?

Hon Robert M Persaud: It is intended for the first crop of next year, but I must say that we made efforts to have the fertilizer in the country in October, but that arrangement that was entered into fell through with the supplier. The supplier had some difficulties, and then we had to re-advertise, because we wanted to do this through a public tender process, so that it was transparent and it is open, and no one could accuse the administration of exercising some preference. In the meantime, we have been able to talk with some of the

regular importers, to ensure that, because there has been a drop globally in the price of fertilizer, and they have been able to bring adequate supplies in, and to assist temporarily in the situation. We have to see this as a dynamic process us and searching for solutions and remedies to global factors which we do not have control over.

Mr Robert HO Corbin: I have one final supplementary question.

The Chairman: One minute Mr Corbin; The Honourable Member Mr. Franklin

Mr Everall N Franklin: Thank you Mr. Chairman. Just for the Minister, could he state what percentage savings, because he said a lot, but he has not given us a figure stating, due to this bulk purchase, how much are we saving? And together with that, what arrangements have the ministry made for the storage of 12,500 tonnes, because that is a perishable product too:

The Chairman: The Honourable Minister of Agriculture,

Hon Robert M Persaud: First of all, the world market price, when we had first gone in terms of seeking a supplier, and I am talking about urea here, and this is primarily for the importation of urea, was in the vicinity of US\$860 per metric tonne. Through the bulk

purchase arrangements and some of the proposals that came in, shows that we could have brought in the fertilizer landed here in Guyana for about US\$540, US\$560 per metric tonne. So you can see the savings there considerable. If you break it down in terms of bag per urea, it was being sold at that time for between \$9,000 to \$11,000 per bag of urea. Based on a proposals we saw, it could have been made available to farmers as low as about US \$6000 per bag. So you can see, between \$4,000, \$3,000 per bag.

In terms of storage, the reason why it is we are seeking to have supplies come in at a particular time, and if you check the advertisement, that is why we say in the advertisement we want the supplies to be in by January, is that we are working it with the cropping pattern, so you do not require much storage space. You are absolutely correct, urea is a very sensitive substance and if it is not stored properly, it can deteriorate. So we are phasing it when GUYSUCO, when sugar requires it, when rice requires it, and also in smaller quantities for the crop sector.

The Chairman: The Honourable Member Mr Robert Corbin.

Mr Robert HO Corbin: Well, part of my question has been answered, because I wanted to really find out from the Minister what was the projection in terms of the percentage of reduction in the cost of fertilizer to

the farmer, and what you are saying, it has been reduced by about seventy percent; am I clear? So that is my question, what percentage?

Hon Robert M Persaud: Mr. Chairman, just let me briefly clarify, because this is a public procurement process, and when it is finalized, the issues of pricing will come at the end of the process. And I was just illustrating for the Honourable Member Mr. Franklin that at that time when we first went out, that could have been the reduction passed on. As I said I am quite sure that the price internationally for urea has gone down and I am not sure what the proposals that we will receive, what they will reflect, and then we would be able to pass it onto the farmers. But the aim is that, if the new GMC imports it, it will be at zero mark-up, just taking care of the cost and distribution of the urea to our farmers.

And as a result of that reform, structural and departmental changes were effected to a number of Government agencies and departments. So that at the Ministry of Home Affairs, if you are to look at how the budget is structured, you will find always that the monies allocated to the Ministry of Home Affairs is usually allocated to the Secretariat, because the way the Ministry is structured. If you look at the organagram of the Ministry, the Minister does not have a Secretariat, but the Secretariat of the Ministry constitutes the Permanent Secretary and all the other accounting staff at the Ministry of Home Affairs. So that when we speak about secretariat services", in effect we're talking about the services provided by the Ministry of Home Affairs. That is how it is structured and if we are to revisit the budgets that have been presented here over the years; you will find that same kind of presentation. Having said that, Mr. Speaker, I

Mrs Deborah J Backer: Thank you very much. Under the same Item No. 4 \$650,000 to facilitate emergency repairs to the Ministry's generator, could the Honourable Minister share with the House how old this generator is?

Hon Clement J Rohee: The last time I went downstairs at the back of the Ministry to visit that generator; it seemed to me that it needs to be replaced. But the cost of a new generator could be somewhat exorbitant. So what we do, we tried to weigh the cost of purchasing a new generator against that of servicing the current generator, and try our best to see how much more we can get out of the generator as it presently is at this point in time. I am sure the Honourable Member would agree that a Ministry such as the Ministry of Home Affairs, cannot be left without any power at any point in time whatsoever, being the nerve centre in respect to the security issues in the country. So in the meantime, while we are considering to import a new generator, we have to at the same time, keep the current one going, because we do not want to throw out the baby with the bathwater, so to speak.

Mrs Deborah J Backer: A Supplementary question -

Could the Honourable Minister say what would be the cost, because he has obviously inquired, he said he weighed one against the other. Could he share with us what would be the cost, if we were to approve a new generator?

The Chairman: The Honourable Minister of Home Affairs

Hon Clement J Rohee: Well I have to approve it first before you approve it, but I have not actually looked at any cost as yet. The Permanent Secretary is in the process of ... [Noisy Interruption]

The Chairman: Allow the Minister, please.

Hon Clement J Rohee: We have to have at least three quotations according to the procedure. And we are currently looking at least two so far. No decision has been made as yet with respect to the purchase of a new generator. We do not want to commit the Ministry of Finance to purchasing anything unless we're aware that resources are available.

Mrs Deborah J Backer: Sir on the exact question.

The Chairman: Unless Mr. Franklin gives way.

Mr Everall N Franklin: The exact question too, I will defer

Mrs Deborah J Backer: You go ahead.

Mr Everall N Franklin: Honourable Minister, could you explain what size the generator is? Because It makes more sense to know what size of generator, and to know you are spending \$650,000 to repair something; it will give us a little more understanding as to what we are really spending on.

Hon Clement J Rohee: Mr. Chairman, I am not a technical person; I am a humble politician and a servant of the Government. I rely on the technicians who come to examine the generator to provide us with all those details. They go to the Ministry of Finance and then they discuss it, and then the Ministry of Finance makes the decision whether they could at any point in time make the resources available.

Mr Everall N Franklin: Well that is the idea, Mr. Minister, because I know that you are a politician and not a technician, it is important to have those questions clarified, because you will be spending multiples of \$650,000 per year, I think this question is valid, so that we can make sense out of this repair costs.

Mrs Deborah J Backer: Sir, in the case where he has two quotations, could he share with this Honourable

House, either of the two or the average, if he does not want for security reasons, he cannot tell us what ... no, because you see, if we know that a new generator is \$5 million, it may make more sense as the Honourable Member said, because we have already approved \$2.5 million, now they are coming for \$650,000, that is \$3,150,000 for the year. So what would be the cost? The Minister must, he does not have to be a technical person to read the quotation Sir.

The Chairman: The Honourable Minister of Home Affairs

Hon Clement J Rohee: I was not anticipating my being asked for quotations, Mr. Chairman or else I would have certainly walked with them. I am not in the habit of walking around with quotations. I walk around with political quotations if needs be.

work is ongoing. That is the issue of mobilizing resources, contributions to the Regional Development Fund. But for reasons that I would think would be reasonably obvious, I would not be in a position to make any projections with respect to what we might be able to mobilize, and by when, and indeed from whom.

What I want to ask the Minister, with 2006 putting us at 80, 2007, 90, with the latest estimates at 645, how it is in 2008, what we saw was zero? Whether there was no plan to deal with this Harbour Bridge that he comes at this late hour for \$32 million? So it seems to me, could he explain why no money was approved, and what exactly this will do to in relation to the charge given by the President not so long ago?

Hon BH Robeson Benn.: Mr. Chairman, the amount specifically relates to the anchor chains for the Harbour Bridge. We have been doing a detailed

engineering inspection and assessment of the bridge and based on the determination of its condition, and the fact that we need to keep this bridge going for another seven years or maybe ten years on the outside, this is the type of expenditure that is needed to be made now, given the condition of the bridge.

Hon Clement J Rohee: I do not have that specific figure, but I think I know why the Honourable Member is more interested in the crash barriers. Well you know, there are lots of protests have been going on within the past couple of months, and the barriers that we have are now inadequate, they need to be reinforced, and bearing in mind that we have not had a replenishment of barriers in recent times; it is obvious that with the resurgence within recent months of protests, we obviously have to equip the police better with barriers in order to deal with any untoward activity.

Mr Everall N Franklin: Mr. Chairman, did the Minister take into consideration, having planned that these crash barriers could be constructed by the Guyana Prison inmates of the Guyana Prison Service? Is there any consideration for that - to save money?

Hon Clement J Rohee: The Guyana Prison Service has recently employed a person, who I understand is trained to do welding and fabrication, and that is an idea that we may want to consider. But recognizing the strength and the force that is sometimes exerted on these barriers, and the numbers sometimes that are

used against these barriers, they have to make sure that they are properly reinforced material that is used to deal with these matters.

The Chairman: The Honourable Member Mrs Backer.

Mrs Deborah J Backer: Could the Honourable Minister share with this Honourable House where the crash barriers were purchased from - which country?

Hon Clement J Rohee: I cannot disclose this at this point in time.

Mr Everall N Franklin: Just a follow-up, is the Honourable Minister saying that indeed these crash barriers were imported?

Mr Everall N Franklin: Mr. Chairman, could I just remind the Minister that we construct ships here in Guyana. Am I to understand that we have the capability to construct ocean-going and river-going vessels, but we cannot construct barriers? You do not have to answer, Minister.

Mrs Deborah J Backer: Could Honourable Minister say whether the bulletproof vests purchased from an unknown country has been supplemented by items that

the Government would have received under the Security Sector Reform Action Plan? Bulletproof vests they would, or were scheduled to receive under the Security Sector Reform Action Plan?

Hon Clement J Rohee: The country may be unknown to the Honourable Member, but it is known to me. Now, the money from the Security Reform Action Plan is grant money, and that would not be budgeted for. But this money was from the Treasury, and the Treasury's resources were used for the purchase of these materials.

Mrs Deborah J Backer: Is the Honourable Minister prepared to share with this Honourable House whether the bulletproof vests that is to be given by way of grant under the Security Sector Reform Action Plan has been received by the Government to date.

Hon Clement J Rohee: I thought the Honourable Member was going to ask whether I was prepared to share a bulletproof vest with her. Mr. Chairman, I am not aware at this point in time whether any bulletproof vest were received by the Guyana Police Force or any section of the security forces. I am not aware.

Hon Samuel AA Hinds: Yes, Mr. Chairman, Honourable Members, you may know that the persons living along the Lamaha embankment there have been squatting, and they have been told from time to time that they should move, and they should look to make other arrangements, and indeed some of them had arrangements in train, and so when it became evident that there is a need for this embankment to run transmission lines between the Kingston station and Sophia, we had a number of meetings with them. And we have arranged for them to move. Each one would be receiving a house lot in some one of the existing schemes, and they would be receiving some assistance also to relocate to the assigned house lots. So this sum of money here covers the charge for the house lots, which would be waived, and also makes provisions for assistance to be rendered in relocating.

Mr Robert HO Corbin. Would the Honourable Prime Minister say whether the same arrangements will apply to those persons who are being rudely removed from Timehri?

Hon Samuel AA Hinds: 1 am not aware of anyone being rudely removed from Timehri..

Mr Robert HO Corbin. I know it is not strictly under the head, so I would not pursue the matter.

Hon Samuel AA Hinds: Wisely!.

Mr Robert HO Corbin: But I would have thought that a bulldozer bulldozing a house is rudely removed, like the roughing up. Your Honour, on this very head if one looks at the project profile, because, under the Electrification Program, I think the reference number is 14, and I' would like some guidance of the Minister, because the project description speaks of extending the distribution network to the unserved areas. Onderneeming, Best, Lusignan Area B, Experiment Track Limliar Village, Four Mile Scheme in Amelia's Ward, and then the next one talks about Port Kaituma, Kato, Orealla and Siparuta, replacing of defective meters, on so on. So I will ask the first question, how this got into this area, under what basis this

expenditure has been added to this project profile? I do not see here anything here, so I stand to be guided by him, as to how the fund is in this project which has to do with rural electrification in these areas.

Hon Dr Ashni K Singh: Mr. Chairman, with your permission, if the Honourable Leader of the Opposition is looking at the same page as I am, I believe he would have before him Project Profile No. 14, and he would note that item 5 under box 7, "Description of Projects", says provision for upgrading of transmission and distribution networks. That, Mr. Chairman, is a direct reference to the fact that a new and upgraded 69KV link is being constructed from Kingston to Sophia for the purposes of exactly as it is described here: to upgrade the transmission and distribution network, but also Mr Chairman, as part of larger project that Government is financing specifically, Mr Chairman, I am sure the Honourable Leader of the Opposition would have read, and indeed it was mentioned extensively during the budget debate, that Government is providing amounts that will total over the course of two years, US \$31 million, to finance the acquisition of a new 20 MW power plant at Kingston, which will necessitate for the purposes of integrating the power that will be generated by that plant which would necessitate a new and upgraded 69KV link from Kingston to Sophia.

And further, Mr Chairman, of course, is our support to GPL, and there are other elements, there are other areas in which Government is of course providing extensive support to GPL, which I am sure the Honourable Member is aware of.

The Chairman: The Honourable Member Mr. Norton.

Mr Aubrey C Norton: Mr. Chairman, the Honourable Prime Minister had indicated they allocated house lots. If we acknowledge that this is the period when the Government is taking about grow more food, and if we also acknowledge that the people on that embankment are planting, could he say whether it is just a house lot, or if they cater for them to continue to contribute to production in Guyana?

The Chairman: The Honourable Prime Minister.

Hon Samuel AA Hinds: It is a house lot that they are getting, and I think other arrangements may be made depending on their circumstances; they have a whole range of circumstances.

Mr. Robert HO Corbin: I will now elaborate to the question I raised in the previous paper. They have here \$650,000,000, provisions for rehabilitative work to the Demerara Harbour Bridge. And again I look at the voted provisions, and I see zero. Is the Honourable Minister saying that they came to this Parliament in budget time, and did not cater a cent for the maintenance of the Harbour Bridge so that we have \$650,000,000 supplementary, when this should have been part of the original allocation? Could the minister tell us something? The President was probably right to scold.

The Chairman: The Honourable Minister of Transport and Hydraulics

Hon BH Robeson Benn: Mr. Chairman, I really do

not want to repeat myself with respect to the need, to assure the integrity of this bridge or the next seven to ten years. The Bridge, as I have said that we have made detailed investigations and assessment of the condition of the bridge, against this horizon of seven to ten years. There were some issues with respect to the deck plating material which was being used, sourced locally, because the original specified material could not have been assessed overseas in the quantities which would have been considered necessary, and also too, we were on an ongoing basis making deck plates at the Demerara Harbour Bridge, that was a constant activity. I think it was well ventilated in the press, that there has been excessive wear and destruction of the deck plating on the bridge, because of overloading and speeding on the bridge, greater dynamic forces are being carried on the bridge. In view of our assessment, in view of the fact that we put in place improved engineering management at the bridge, this is the sum that is considered necessary to address these problems now.

Mr Robert HO Corbin: Mr Chairman, I gather that the Minster is telling us that the speeding and heavy use of the bridge started in March of this year. If that the point he is making?

Hon BH Robeson Benn: Mr. Chairman, I think I did say too publicly in the press, and I am simply restating

it hear, that we have had an explosion of housing construction oo the West Bank and on the West Coast of Demerara. And the amount of trucks, and the amount of tonnage being carried over that bridge now, and the rate at which it is being carried over, is in excess of the specification of the material which is being used. And that is indeed the reason why we need to address the matter

The Chairman: The Honourble Member Mrs. Backer

Mrs Deborah J Backer: Mr. Chairman, I wonder if the Honourable Minister would be kind enough to inform this House that when he looked at the bridge, when his technical people carried out an assessment of the bridge pre-budget too again, he was satisfied that no maintenance, absolutely no maintenance, would have been necessary for the entire duration of 2008, and would he be man enough to say that in retrospect, would he be brave enough - Minister enough - to accept, to accept that it was obviously an oversight and bad judgment in on his part?

Hon BH Robeson Benn: Mr. Chairman, it seems that the Honourable Member did not pay attention to the fact, when I said that there was ongoing maintenance being done by the Demerara Harbour Bridge Corporation. The Demerara Harbour Bridge is a Corporation by itself, these are sums being assigned by the Government as subsidies towards the Corporation.

The Corporation by itself is spending money on a daily basis with respect to the maintenance of the bridge.

communicate ideas and information without interference and freedom from interference with is correspondence".;

AND WHEREAS the people of Linden and Wismar have expressed to the leadership of the Alliance For Change their frustration and anger at being denied the right to access local and external television channels other than NCN Channels 11 and 8 operated by the State,

## BE IT RESOLVED:

That this National Assembly endorses the fundamental rights of these citizens to receive ideas and information without interference via television media other than those which are provided by NCN;

AND BE IT FURTHER RESOLVED:

That this National

Assembly calls on the Government of Guyana and its National Frequency Management Unit to permit operators of private television channels in Guyana the right to relay and beam their cannels in Linden and Wismar without having to attain additional licenses and pay additional fees;
