Minutes of the Proceedings of the 15th Meeting of the Committee of Selection held on 3 November 2005.

STATEMENTS BY MINISTERS

(i) On the Level of Price Cut for ACP Sugar to the EU

The Speaker: The Honourable Minister of Foreign Trade and International Co-operation

Hon Clement J Rohee: Mr Speaker, the long awaited level of price cut for ACP Sugar exported to the European Union was announced a few hours ago.

According to reports emanating from Brussels, the price cut is thirty-six

percent. For Europe, the producer price for sugar will be reduced in four stages with accumulative reduction of four years - twenty percent, twenty-five percent, thirty percent and thirty-six percent. It is not clear whether this formula will be applicable in ACP countries in light of the commitment given to CARICOM Leaders by British Prime Minister Tony Blair to lengthen the transitional period. Further it is not clear, what is the nature of the concession to be offered to ACP sugar supplying states in light of the new dispensation.

Mr Speaker the decision of the EU to proceed with such a hefty price cut is outrageous and unconscionable and so to add insult to injury the EU beet sugar producers will now receive compensation covering 64.2 percent inclusive of an additional 2.2 billion Euros to cover the loss incurred by the price cut. In contrast a meagre 40 million euros have been offered to ACP sugar producers as compensation.

Guyana along with other CARICOM sugar producing countries will now have to gird their loins for another round of the battle. ACP countries have stated that they are prepared to accept a price cut of nineteen percent. The EU has now declared the price cut of 36 percent. This therefore creates a framework for negotiations between the ACP and the EU on the level of price cut for ACP countries.

Further the battle with respect to the level of compensation needed to offset the impact price cut on the economies of the ACP countries remains unresolved. ACP countries have called on the EU to provide up front adequate financial resources, on a secured and automatic basis, that is 100 million Euros for 2006 and 500 million Euros yearly thereafter to allow them to adjust to the reform process.

The regions sugar industry has been taking steps to adjust to these challenges. The modernization plant for GUYSUCO is a case in point.

In addition, studies show that the Sugar Industry in Guyana is one of the few industries of the ACP sugar supplying States that will manage to survive the price cut. Guyana's action plan to address adjustment cost

and compensation needs will soon be finalized for submission to the European Commission. A trade based solution by way of securing greater market access to the EU and other markets or countries who can deliver profitably at new prices and to offset the price loss is a course of action among others that we are likely to pursue. This is in keeping with our vision of the future of the sugar industry in Guyana.

(ii) Upcoming Ministerial Conference of the World Trade Organisation in Hong Kong

Mr Speaker, I now wish to make another statement on the upcoming Ministerial Conference of World Trade Organization in Hong Kong.

Mr Speaker, Trade Ministers of the World Trade Organization will be meeting in Hong Kong for the 6th WTO Ministerial Conference on 13-18 December 2005, to assess the state of play in the current Doha Development Trade Negotiations and renew relevant mandates for the conclusion of the negotiations by the end of 2006.

On 9 September 2005, I issued a statement to the media warning that the Doha Development Round was tethering on the brink of collapse. In that statement, I said, Hong Kong should aim for limited success and the level of expectations scaled down if that limited success is to be achieved.

Subsequently, in conversations with the Minister of Trade, Industry and Technology from Hong Kong, who visited with us in early November, the view was expressed that in light of much anticipated turbulence in the run up to Hong Kong, an early harvest of re-calibrated expectations should be agreed in order to ensure success at the Ministerial meeting. At the same time, we should do out utmost to maintain the deadline for completing the round in 2006.

Mr Speaker, the expectations of the Hong Kong meeting had to be reduced considerably due to the fact that the industrialized countries and the G20 Brazil and India included cannot reach agreement on the full modalities for market access for agriculture and industrial goods and the phasing out of export subsidies and domestic support by an agreed date. In this regard the key areas of contention in the current negotiations are:

- 1. Agreeing to a tariff reduction formula with special and differential provisions for agriculture products; and
- Settling a tariff reduction formula with special and differential provisions for industrial goods.

Without an agreement on these two areas, the Doha Development Round cannot go forward. At the same time, apart from mainstreaming the Sand D Provisions and ensuring that the interest of small economies are entrenched topic by topic in the current negotiations, the much debated question of long standing preferences and preference erosion are yet to be resolved.

Mr Speaker regrettably and much to the dissatisfaction of the ACP countries of which Guyana is an integral part, these issues have been relegated to the back burner. For Guyana and CARICOM as a whole, the development dimension of the Doha Round is vitally important, but continues to be neglected in the negotiating agenda.

At a preparatory meeting of the Caribbean Trade Ministers held last week in Barbados, which included Cuba and the Dominican Republic, we agreed that the legitimate interest of the small vulnerable economies of the Caribbean must be adequately reflected in the negotiating agenda in order for the region to join any consensus at Hong Kong. In other words the region must not be worst off at the end of the round than when it commenced.

CARICOM has repeatedly reaffirmed its support for the WTO talks, but there are grave misgivings on how these talks are being conducted. The Region has made it clear that it is not prepared to compromise on the preservation of long standing preferences for bananas and sugar for example, and more generally special and differential treatment in which no substantive progress have been made since the 5th meeting in Cancun.

Substantive progress must be made on agreements specific, special and differential proposals if Hong Kong is to be successful albeit in a limited way.

Mr Speaker, long standing preferences constitute a vital concern for the ACP as a whole and Guyana has supported the group's position not to join in any consensus decision on agriculture unless the erosion of preferences is effectively addressed through concrete and meaningful measures to mitigate the impact of reform on the preference receiving countries. Failure to do so will impose a disproportionate share of the cost of reform on some of the poorest and more vulnerable members of the World Trade Organization.

Mr Speaker, our agenda for the Hong Kong meeting will include the following bottom line or Category I issues:

- Special and differential treatment for small, vulnerable and commodity dependant economies;
- A special safeguard mechanism;
- 3. A special sensitive product category;
- 4. Maintenance of long standing preferences; and
- 5. Aid-for-trade packages to compensate for preference erosion

Unless there vitals issues are made operational in specific clauses, we cannot subscribe to any declaration, re-calibration of the level of ambition or statement of good intention emanating from Hong Kong.

Mr Speaker, in pursuant of these objectives, we are committed to joining forces with like-minded countries and groups within the WTO's membership such as the Group of 33, the G 90 and the G 20. Practical

and strategic alliances will be struck with these groups bearing in mind our short, medium and long-term goals.

Mr Speaker, Guyana is going to Hong Kong as an integral member of a Caribbean team including Cuba and the Dominican Republic. We will also be part of the wider ACP and G90 groupings. In this way, we will work to influence the outcome of Hong Kong and to ensure that the development dimension of the Doha Round remains in focus and irrevocably entrenched in any future mandate. Thank you.
