### STATEMENTS BY MINISTERS

**Senator Hubbard** (Minister of Trade and Industry): Your Honour, while we were debating the Financial Administration and Audit Bill, 1961, you raised a question regarding the authority of the Director of Audit in regard to private documents, and I undertook to have the matter clarified

and to inform you of the position. I am now ready to do so. The position is as follows:

Section 23 (2) of the 1961 Bill states —

"The Director of Audit may authorise any officer of his department to perform on his behalf any of his duties or functions under this Ordinance or any other Ordinance other than the certifying and reporting of accounts for the Legislature."

The present position is outlined in the Audit Department Ordinance, Chapter 69, which states (Section 6) —

"Any of the powers of the Director of Audit for securing a proper audit may be exercised by any officer or clerk authorised by him in that behalf in writing or by any person approved by the Governor."

It follows therefore that the proposed Bill contemplates no widening of the power in this respect. Indeed, if anything, the provision in the new Ordinance is more restrictive — the functions of the Director of Audit may be delegated to officers of his department.

It is clear, on examination of the two sections, that the new legislation does not merely re-enact the section giving powers to the Director of Audit. Indeed, it restricts those powers since the Director of Audit could now only delegate his powers to an officer of the Department; whereas the old legislation allowed those powers to be delegated to any person approved by the Governor.

**The Vice-President:** Thank you for your explanation.

### PUBLIC BUSINESS

#### MOTIONS

ORDER IN COUNCIL NO. 72 OF 1961

**Senator Hubbard:** Your Honour, I beg to move:

"That this Senate in terms of section 9 of the Customs Ordinance, Chapter 309, confirms Order No. 72 of 1961

which was made on the 7th day of November, 1961 and published in the Gazette on the 18th day of November, 1961."

Order No. 72 is the legislative provision to give effect to an international convention dealing with tourists to provide that they should have the right to bring in motor vehicles on a temporary basis and prescribe what they could bring in by way of baggage and the like. This is a provision which has been brought into effect in many lands and this Order is intended merely to bring us up-to-date in this connection.

**The Vice-President:** Are they permitted to bring in motor vehicles?

**Senator Hubbard:** On a temporary basis. [*Pause.*] No, sir, I am mistaken.

**The Vice-President:** Except you want to say that it comes under "sport".

#### ORDER IN COUNCIL NO. 74 OF 1961

##### TAXATION CONCESSION TO TEXTILE INDUSTRY

**Senator Hubbard:** Your Honour, it is considered desirable that certain taxation concessions should be given in respect of the textile manufacturing industry, an industry which has not yet been set up but which we hope will be set up in due course, to provide free entry of certain raw materials when they come from preferential sources and at a reduced rate of duty when they come from foreign sources; and to give effect, I beg to move

"That this Senate in terms of section 9 of the Customs Ordinance, Chapter 309, confirms Order No. 74 of 1961 which was made on the 22nd day of November, 1961 and published in the Gazette on the 2nd day of December, 1961."

#### CONTINUANCE OF RENT RESTRICTION ORDINANCE

**Senator Nunes** (Minister of Education and Social Development): Your Honour, in moving the Motion standing in my name, I should like to report that an acute housing shortage still exists in this country, and Government has found it necessary, therefore, to continue its protection of tenants in buildings and on house lots throughout the country. I, therefore, formally move that

"Whereas the Rent Restriction Ordinance, Chapter 186, came into operation on the 8th day of November, 1941;

And Whereas section 33 of the said Ordinance provides that the Ordinance shall continue in force up to and including the 31st day of December, 1951, but that, prior to the expiration thereof, the Legislative Council may, by resolution published in the Gazette, declare that the said Ordinance shall continue in operation for a further period of one year, and that thereafter may from time to time declare that the said Ordinance shall continue in operation:

And whereas the said Ordinance has been continued in operation until the 31st December, 1961;

And Whereas it is considered expedient that the said Ordinance shall be continued in operation for a further period of one year:

Now, therefore, be it resolved: That the Rent Restriction Ordinance, Chapter 186, shall continue in force for a period of one year up to and including the 31st day of December, 1962."
