TAX (AMENDMENT)(NO. 2) BILL 1974 - Bill No. 16/1974 published 11.6.74

A BILL intituled AN ACT TO AMEND THE TAX ACT.

The Bill was then read a second time and was, thereafter, taken through its remaining stages and <u>passed</u> as <u>printed</u> with the following corrections:

(i) <u>Clause 2:</u>

Substitution of the word "persons" for the word "person" in the second line of the definition of "promoter" in paragraph (a).

- (ii) <u>Clause 3:</u>
 - (a) <u>Substitution</u> of the word "for" for the word "of" at the beginning of the second line of paragraph (e).
 - (b) <u>Substitution</u> of "to section 63(1)" for "section 63(1)" at the end of paragraph (e).
