ITEM 2 - GUYANA FORESTRY COMMISSION BILL 1978 - Bill No. 27/1978 published 23.12.78

Corrections

Renumbering of paragraph 4 (1) as sub-paragraph (4).

Substitution of "Fivo members of the Commission shall constitute a" for the first line of the renumbered sub-paragraph (4).

Substitution of "co-opt" for "coopt" in sub⊸paragraph (6).

Paragraph (8)

Substitution of "ellowances" for "allowance" in the third line.

Insertion of a closing bracket after "member" in the seventh line:

Second Schedule

Forests Act (Cap. 67:01)

Insertion of closing quotation marks after "Commission"
in the amendment to section 5(1) (b).

Guyana Timber Export Board Act (Cap. 67:03)

Insertion of "Act" after "Board" in the title.

Timber Marketing Act (Cap. 67:04)

Substitution of a single closing quotation was in the last line of the amendment to section 2.

Second Reading

The Minister of Energy and Natural Rosources moved the second reading of the following Bill:

Renumbering of the clause as clause 4(1) and insertion of the following as subsection (2) -

"(2) Whore the exercise of any function by the Commission under this Act or any other law is subject to the approval of the Minister, it shall not be necessary to obtain that approval if the Minister is the Chairman of the Commission.".

Clauses 5 to 35 were passed as printed.

First Schodule was passed as printed.
Second Schedule was passed as printed.

Assembly resumed.

Third Reading

On a motion by the Minister of Energy and Natural Resources, the Bill was read the third time and passed as corrected and amended.

ADJOURNMENT

At 7.17 p.m., on a motion by the Minister of Parliamentary Affairs and Leader of the House the Assembly was adjourned to a date to be fixed.
