# ITEM 3 - ACQUISITION OF THE UNDERTAKING CARRIED ON BY THE MAYOR AND TOWN CAUGGIL OF NEW AMSTERDAM

The Minister of Energy and Natural Resources moved the following motion, and the following amendment thereto:-

#### Motion

WHEREAS the Electricity Act, Chapter 56:01, provides for the Guyana Electricity Corporation to have the exclusive right to generate and sell energy within the areas prescribed in the First Schedule to the Act;

AND WHEREAS the Mayor and Town Council of New Amsterdam are empowered by the New Amsterdam Electric Lighting Order 1900 made under the Electric Lighting Ordinance 1890, as amemded from time to time, to supply electricity to the area mentioned in the First Schedule to the said Order;

AND WHEREAS by virtue of the New Amsterdam Eletric Lighting Order (Extension) Ordinance 1961 and the New Amsterdam Electric Lighting Order(Extension) (Amendment) Act 1971 the Order continues in force until 1st January 1981;

AND WHEREAS it is provided by section 24(1) of the Electricity Act, Chapter 56:01, that the Electricity Corporation may acquire the undertaking of any local authority or person authorised to supply electricity within an area;

AND WHENEAS such provision requires a resolution of the National Assembly that it is in the public interest that the undertaking of the Mayor and Town Council of New Amsterdam for the supply of electricity should be managed and worked by the Electricity Corporation:

## BE IT RESOLVED:

That it is in the public interest that the undertaking carried on by the Mayor and Town Council of New Amsterdam should be acquired by the Guyana Electricity Corporation.

#### Amendment

 $\underline{\text{Deletion}} \text{ of the words "should be acquired" and} \\ \underline{\text{substitution}} \text{ of the words "for the supply of electricity should} \\ \text{be managed and worked" in the $R_{\text{e}}$solve Clause.}$ 

The Deputy Speaker and Mr. Singh spoke to the motion.

The motion was then put and carried as amended.

# ITEM 4 - CONFIRMATION OF CONSUMPTION TAX (AMENDMENT) NO. 2 ORDER 1979 (No. 87)

The Minister of Finance moved the following motion:

BE IT RESOLVED:

That this National Assembly in accordance with section 5 of the Consumption Tax Act, Chapter 80:02, confirm the Consumption Tax(Amendment) (No. 2) Order 1979 (No. 87), which was made on 22nd October, 1979, and published in the Gazette on 27th October, 1979.

The Deputy Speaker spoke to the motion.

Thereafter, the motion was put and carried.
