Insertion of the following after the amendments to the Status of Aliens Ordinance, Chapter 102:-

> "National Security (Miscellaneous Provisions) Act, 1966, section 9.

In paragraph (c) of subsection (2), the word "information" shall be substituted for the word "evidence".

NatiOnal Security (Miscellaneous Provisions) Act, 1966, section 12. In subsection (2), the following words shall be added between the words "shall" and "come" - The Schedule was under consideration when the time for the suspension of the sitting was reached.
