- (b) <u>Renumbering</u> of subsection 4(d) and (e) as subsection 4(e) and (f) respectively.

Clause 2 was then passed as printed.

Assembly resumed

# ITEM 3 - DTION TO APPROVE OF THE REMISSION OF STAMP DUTY TO THE PROMOTERS OF THE AFRICAN APOSTOLIC BROTHERHOOD CHURCH, BETHESDA (INCORPORATION) BILL, 1969

On a motion by Miss Ackman and seconded by Mr. Van Sluytman, the following motion was put and <u>carried</u>:

WHEREAS on the 6th of August, 1968, in accordance with Standing Order No. 57(5)(b) and section 9(33) of the Tax Ordinance, Chapter 298, the Promoters of the African Brotherhood Church, Bethesda (Incorporation) Bill, 1968, paid to the Accountant General the prescribed stamp duty of \$100.00;

# THE PROMOTERS OF THE FULL GOSPEL FELLOWSHIP OF CHURCHES IN CUYANA (INCORPORATION) BILL, 1968

WHEREAS on the 23rd of July, 1968, in accordance with Standing Order No. 57(5)(b) and section 9(33) of the Tax Ordinance, Chapter 298, the Promoters of the Full Gospel Fellowship of Churches in Guyana (Incorporation) Bill, 1968, paid to the Accountant General the prescribed stamp duty of \$100.00;

AND WHEREAS the Bill was enacted by Parliament on the 4th of November, 1968;
