PERSONAL EXPLANATIONS

Newspaper article on the annulment motion concerning the duty allowance paid to Members of the Assembly

Mr. Ram Karran drew the Speaker's attention to an article by 'Lucian' in that day's issue of the Guyana Graphic, concerning his notice of a motion to annul the Order (Order No. 17 of 1969) made by the Minister of Finance. He objected to the language used in the article and contended that it violated the privileges of the Assembly.

Dr. Ramsahoye supported the views expressed by Mr. Ram Karran.

His Honour the Speaker agreed that the comments in the penultimate paragraph of the article was comtemptuous of the privileges of the Assembly, not only in the way it was written but also having regard to the fact that it contained the word "hypocrisy" - an unparliamentary expression. He expressed the hope that 'Lucian' would acknowledge his error and in a subsequent article make an apology to the Assembly. INTRODUCTION OF BILLS -

> A BILL intituled AN ACT TO PROVIDE FOR THE IMPOSITION OF A CONSUMPTION TAX ON GOODS IMPORTED INTO GUYANA OR MANUFACTURED THEREIN; FOR THE COLLECTION AND ENFORCEMENT OF SUCH TAX, AND FOR MATTERS INCIDENTAL THERETO OR CONNECTED THEREWITH.

PUBLIC BUSINESS

BILL - Second and Third Readings

ITEM 1 - VALUATION FOR RATING PURPOSES BILL, 1969 - Bill No 9/1969 published 17.5.69

The Minister of Local Government moved the second reading of the following Bill:

A BILL intituled AN ACT TO MAKE PROVISION FOR THE VALUATION OF PROPERTY FOR RATING PURPOSES AND FOR MATTERS CONNECTED THERETIWH.

Mr. Ram Karran, Mr. Wilson, Mr. Hamid and Mr. Sutton spoke to the motion.

The question was then put and carried.

The Bill was then read a second time.

Assembly resolved itself into Committee to consider the Bill clause by clause.

In Committee

Clauses 1 to 26 were passed as printed.

Clause 27

The following amendment by Dr. Ramsahoye was put and negatived:

Deletion of the words "on any question of law" from subsection (9).

Clause 27 was then passed as printed.

Clauses 28 to 45 were passed as printed.

Clause 46

The following amendment by the Minister of Local Government was put and <u>carried</u>:

Deletion of the words "as if it were a valuation list made under this Act" from subsections (1), (2) and (3).

Clause 46 was then passed as amended.

Clause 47 was passed as printed.

The First and Second Schedules were passed as printed.

Assembly resumed.

On a motion by the Minister of Local Government, the Bill was read the third time and passed as amended in Committee.

ITEM 2 - MOTION TO ADOPT THE REPORT OF THE STANDING ORDERS COMMITTEE

The Minister of Trade and Parliamentary Affairs moved the following motion:

BE IT RESOLVED:

That the Report of the Standing Orders Committee on the revision of the Standing Orders as in force in the previous House of Assembly prior to the 26th of May, 1966, and which are still in force as the rules of procedure of the present National Assembly, be adopted.

Mr. Hamid spoke to the motion.

Thereafter the question was put and carried.
