QUESTION NO. 2

Mr. Wilson asked the Minister of Labour and Social Security the following question:

Question: Will the Minister say -

- (i) what date the National Aid Board was established and the date of its first meeting?
- (ii) whether meetings were held weekly, fortnightly, monthly or quarterly?
- (iii) what is the number of meetings held by the Board since its establishment and the number that fell through for the want of a quorum?

The Minister of Labour and Social Security gave the following reply:

Answer: (i) 28th September, 1966; 12th October 1966.

- (ii) Meetings were first held weekly up to May 1967; then on the second and fourth Wednesdays up to April 1968. Since then, meetings are held, up to the present time, on the second and fourth Tuesdays.
- (iii) 49 meetings were held; 18 "fell through".

Mr. Wilson to ask the Minister of Labour and Social Security the following question:

Question: Will the Minister say -

- (i) what is the number of applications received by the National Aid Board?
- (ii) what is the number investigated to date?
- (iii) what is the number of applicants granted assistance and what percentage does this represent of the number of applications?

The Minister of Labour'and Social Security gave the following reply:

Answer:

- (i) 2,625 applications have been received by the National Aid Board.
- (ii) 1,055 applications have been investigated to date.
- (iii) 789 granted assistance representing approximately 30%.

MOTION TO WRITE-OFF \$3,173,672.67 REPRESENTING BAD DEBTS WRITTEN-OFF BY THE CREDIT CORPORATION ON 30TH JUNE, 1966

In accordance with article 80(2) of the Constitution, the Minister of Finance signified the Cabinet's recommendation and moved the following motion:

BE IT RESOLVED:

That this National Assembly approve of the write-off against the outstanding loans made by the Government to the Guyana Credit Corporation totalling fourteen million, seven hundred and fifty-eight thousand, nine hundred and eighty-seven dollars and sixty-two cents (\$14,758,937.62), of the sum of three million, one hundred and seventy-three thousand, six hundred and seventy-two dollars and sixty-seven cents (\$3,173,672.67) representing bad debts written-off by the Corporation on 30th June, 1966, as summarised in the undermentioned schedule, together with the interest that has accrued thereon to date.
