TRAFFIC (AMENDMENT) ACT, 1969 (NO. 34)

ITEM 5 - MOTION TO EXEMPT THE BANK OF GUYANA FROM THE PROVISIONS OF THE PROPERTY TAX ORDINANCE

The Minister of Finance moved the following motion:

WHEREAS the Bank of Guyana is not exempt from the provisions of the Property Tax Ordinance, 1962 (No. 19);

AND WHEREAS it is provided under Part III, section 6(w) of the Property Tax Ordinance, 1962,

that any person or authority may be exempted from the provisions of the said Ordinance by resolution of the National Assembly:

BE IT RESOLVED:

That this National Assembly approve of the Bank of Guyana being exempted from the provisions of the Property Tax Ordinance, 1962 (No. 19).

Dr. Ramsahoye spoke to the motion.

Thereafter, the Minister of Finance replied.

The motion was then put and carried.
