#### QUESTIONS TO MINISTERS

#### Question No. 32

Mr. Reepu Daman Persaud asked the Deputy Prime Minister and Minister of National Development and Agriculture the following question:

- Question: (i) Will the Minister say whether it is true that Government proposes to merge the Guyana Rice Corporation and the Rice Marketing Board?
  - (ii) If so, will Government state reasons for the proposed merger?

# (iii) Will the Minister say -

- (a) what are the liabilities of the Rice Development Corporation (RDC) to the Commonwealth Development Corporation (CDC)?
- (b) what were the annual gains or losses of the Guyana Rice Corporation from 1965 to the end of 1971?
- (iv) Will the Minister say whether rice farmers who had already sold their paddy at the "old" prices to the Guyana Rice Corporation and other rice millers for the crop year 1971-72 will get pro rata increases on account of the new increased prices for rice?

The Deputy Prime Minister and Minister of National Development and Agriculture gave the following reply:

# Answer:

- (i) It is planned to merge the Rice Marketing Board and the Rice Corporation thereby creating a single institution to serve the rice industry.
- (ii) For many years, the two organisations, though under separate managements, have been operated in unison. Merger is, therefore, merely a formality. Nevertheless when it takes place, the following benefits will result:
  - (a) A single organisation, rather than two, will save management and operating costs;
  - (b) the economic and financial benefits of vertical integration will result by combining, into a single entity, the production organisation (GRC) and the marketing organisation (RMB):
  - (c) consolidation of the assets of the two organisations will increase the operating strength and financial bargaining position of the new unit. Borrowings for working capital will be reduced and greater efficiency achieved in the use of physical and money resources;
  - (d) the technical skills and manpower available to the two bodies will be more effectively and efficiently employed; and
  - (e) the cumulative effect of the above will be better services for rice farmers with consequential financial and other benefits to them.

- (iii) (a) The Guyana Rice Corporation has no liabilities to the Commonwealth Development Corporation.
  - (b) The Guyana Rice Corporation came into existence on 26th August 1969. From that time, its operations have been closely linked to those of the Rice Marketing Board. The policy has been to reflect traing surpluses in the accounts of the Rice Marketing Board, while the Guyana Rice Corporation undertook various programmes of assistance to farmers and certain non-profitable activities to encourage production. Accordingly, the accounts of the two organisations are not intended to be considered in isolation of each other but rather together. The net surpluses resulting from the operations of both organisations were as follows:-

1969/70 - \$660,119 1970/71 - \$454,957

(iv) In the past, increased riceprices were usually announced on 1st October, that is, after the main crop was already planted and reaping had commenced. Farmers did not know of the increased prices, therefore, until after they had planted and had begun to reap the crop. Farmers were denied the opportunity, therefore, of planting the largest possible acreage to take full advantage of the price increase. However, on this occasion increased prices were announced in June in order to stimulate farmers into planting as much rice as possible so as to benefit fully from higher prices at harvest time in September/October 1972 and thereafter.

AND WHEREAS it is necessary to raise a loan in the sum of one hundred and fifty thousand United States dollars, for the purpose aforesaid;

AND WHEREAS Barclays Bank International Limited, at 120 Broadway, New York, N.Y. 10005 is willing to make available a loan in the sum aforesaid for the purpose aforesaid, at a rate of interest 1½ per cent above the New York prime rate prevailing during the repayment period, repayable in monthly instalments of t.S. \$1,500, the first instalment to be paid on the last day of September, 1972 and the last instalment to be paid on the last day of August, 1985;

#### NOW THEREFORE BE IT RESOLVED:

That this National Assembly in pursuance of section 4 of the Public Loan Ordinance 1966 approve of the raising from Barclays Bank International Limited, New York, of the loan aforesaid, in the sum aforesaid, for the purpose aforesaid, such loan to be repaid at the times and in the manner hereinbefore specified.
