Assembly first met on Friday, 4th May, 2001. Mr. Kadir was appointed an ordinary Member of Parliament on the 17th April, 2001 and serve in the Eighth Parliament. Mr. Kadir was also Chairman and Vice-Chairman of the Parliamentary Sectoral Committee on Natural Resources. Mr. Kadir ceased to be a Member of Parliament on the 2nd May, 2006, when the Eighth Parliament was dissolved on that date.
