RESOLVED, That this Co ncil approves of the service prior to the 1st January, 1955, of persons employed as domestic employees on and after that date at Government House being deemed to be service with the Government so that such service may be included in calculating the superannuation benefits to be paid to such employees on their retirement in accordance with the existing rules governing such awards approved by Council by Resolution No. LII of the 6th July, 1951 as amended by Resolution No. LVI of the 8th May, 1957.
