CONFIRMATION OF MINUTES

The Minutes of the Meeting held on Thursday, the 19th of May, 1960, as printed and circulated, were taken as read and confirmed.

PUBLIC BUSINESS ORDER OF THE DAY

MOTIONS

Item 1 - MR. BOWMAN'S MOTION CONCERNING THE GRANTING OF FREEHOLD TITLES ON A HIRE-PURCHASE BASIS.

Council resumed the debate on the following motion:

WHEREAS the social and economic system which prevails in British Guiana is patterned on that of the Western World, India and Pakistan and provides for free enterprise and the ownership of property;

AND WHEREAS the policy of the Majority Party of the Government is opposed to freehold ownership of land:

BE IT RESOLVED:

That this Council urges upon the Government that freehold title on a reasonable hire-purchase basis be granted to -

- (i) farmers in respect of land they now occupy in Government Land Settlement Schemes; and
- (ii) persons occupying Crown Lands for farming.

Mr. Jackson resumed his speech, and on a motion by Mr. Kendall seconded by Mr. Burnham, was granted an extension of half an hour.

Mr. Jai Narine Singh and Mr. Tasker spoke to the motion.

Mr. Bowman then replied.

In terms of Standing Order 33(12)(b), the Minister of Trade and Industry was granted leave to speak to the motion.

Thereafter, the Deputy Speaker put the following amendment which had been moved by Mr. Fredericks and seconded by Mr. Davis at the meeting held on Wednesday, 18th May, 1960:

BE IT RESOLVED:

That this Council recommends to Government that requests from persons desirous of obtaining freehold titles be granted and that payment for such titles be accepted in instalments over a reasonable period of time in respect of -

- (i) lands occupied on Government Land Settlement Schemes, and
- (ii) Crown Lands beneficially occupied for farming.

AND BE IT FURTHER RESOLVED:

That the condition of any such sale of land be such that continuous maximum utilisation is guaranteed not only in the interest of the purchaser but also that of the common good.

The amendment was negatived on the following division: -

The original motion was then put and negatived.

Item 2 - MR. SAFFEE'S MOTION RE FLAG, COAT OF ARMS AND NAME FOR BRITISH GUIANA.

On behalf of Mr. Saffee, Mr. Ajodha Singh moved and Mr. Rai seconded the following motion: -

BE IT RESOLVED:

That this Council recommends to Government the appointment of a Committee to -

> design a national flag and a coat of arms; and recommend an appropriate name for a politically free and independent British Guiana.

Mr. Benn moved and Dr. Jagan seconded the following amendments which were accepted by the mover and seconder of the motion:-

- (i) <u>Deletion</u> of the word "and" at the end of paragraph (a);
 (ii) <u>Renumbering</u> of paragraph (b) as paragraph (c);
 (iii) <u>Insertion</u> of the following new paragraph (b):
- - "(b) compose a national anthem; and".
 - Mr. Burnham suggested the following amendment:-

<u>Insertion</u> of the words "from this House" between the words "Committee" and "to".

Mrs. Jagan, Mr. Jackson, Mr. Campbell and Mr. Fredericks spoke.

Mr. Kendall moved and Mr. Jackson seconded the following amendment: -

Substitution of the words -

- (i) "That this Council authorises the appointment of a Select Committee of this Council charged with the responsibility for" for the words "That this Council recommends to Government the appointment of a Committee to"; and
- (ii) "designing", "composing" and "recommending" for the words "design", "compose" and "recommend".

Mr. Burnham rose to speak when the hour of adjournment was reached.
