#### QUESTIONS TO MINISTERS

#### Question No. 20

Mr. Merriman asked the Minister of Labour, Health and Housing the following question:

#### QUESTION: Does Government propose to pass transport to the lessees at La Penitence Village for the lands they occupy? If so, when?

The <u>Minister of Labour, Health and Housing</u> gave the following reply:

ANSWER: Government proposes to pass transport to those tenants at La Penitence who can establish claims of occupancy to the land they occupy except where the land is required for public use in accordance with a planning scheme to provide certain necessary improvements to the village for the benefit of the community. This planning scheme is now under preparation and it is hoped that this will be approved and ready for implementation early in 1963.

## INTRODUCTION OF BILL - First Reading.

TRANSPORT AND HARBOURS (AMENDMENT) BILL, 1962. (Bill No. 17/1962 (L.A.) published 7.7.62)

After discussion, the question was put and the amendment negatived.

Item 8: HEAD 18 - MINISTRY OF HOME AFFAIRS.

Subhead 7. Expenses General Elections .. \$14,915:

and Item 1 of the Supplementary Schedule .. \$ 1,680:

(To provide for payment of unpaid Accounts from 1961. Also to meet remainder of this year's salary for the Commissioner of Elections not provided for in this year's Estimate).

The above items were passed as printed.

Items 9 to 18: were passed as printed.

Item 19: HEAD 57 - PENSIONS AND GRATUITIES.

Subhead 23. Ex gratia payment to Mrs. Gladys King .. \$1,860:

At the request of the Minister of Finance, the figures "\$1,860" were amended to read"\$1,868" and the item was passed as amended.

Items 20 and 22: were passed as printed.

Item 23: HEAD 44 - MINISTRY OF EDUCATION AND SOCIAL DEVELOPMENT.

Subhead 1. Personal Emoluments .. \$1:

(To provide for the appointment of a Cultural Officer at salary of \$8,640 p.a. to advise the Minister of Education and Social Development on Cultural matters).

At the request of the Minister of Natural Resources, the salary of the post of Cultural Officer was amended to read \$7,200 p.a. instead of \$8,640 p.a. as printed.

Thereafter, the item was passed as amended.

Supplementary Schedule of Additional Provision on the Recurrent Estimates

Items 2 to 4: were passed as printed.

The total of the Schedule was accordingly <u>reduced</u> by \$1: and passed at \$170,801:

Committee of Supply then adopted the following Resolution:

RESOLVED, That this Assembly approves the proposals set out in Financial Paper No. 1/1962 - Schedule of Additional Provision on the Recurrent Estimates for June, 1962, totalling \$170,801.

Assembly resumed.

The Minister of Finance reported that Committee of Supply had considered and approved of Financial Paper No. 1/1962 as amended and moved that Assembly agree with Committee of Supply in its Resolution.

Assembly agreed.

The Minister of Finance moved the following motion:-

BE IT RESOLVED:

That this Assembly approves the proposals set out in Financial Paper No. 2/1962 - Schedule of Additional Provision on the Development Estimates for the months of January to June, 1962, totalling \$408,912.

Assembly then resolved itself into Committee to consider the Schedule in detail.

HEAD VII - HEALTH.

7. Skeldon Hospital .. \$54,138:

At the request of the Minister of Finance, subhead 7 was <u>increased</u> by \$7,754: and passed at \$61,692:

HEAD X was passed as printed.

The Schedule was accordingly <u>increased</u> by \$7,754: and <u>passed at \$408,912:</u>

Assembly resumed.

The motion was then put and adopted.

# Item 3 - NATIONAL DEVELOPMENT SAVINGS LEVY BILL, 1962 - Bill No. 16/1962 (L.A.)

The Minister of Finance informed the Assembly that following discussions with the Trades Union Council, it was proposed that the second reading of the BILL intituled AN ORDINANCE TO MAKE PROVISION FOR THE LEVY OF COMPULSORY SAVINGS TO BE UTILISED FOR WORKS OF DEVELOPMENT IN BRITISH GUIANA, AND FOR THE ISSUE OF BONDS THEREFOR, THE PAYMENT OF INTEREST THEREON AND OF PRIZES WITH RESPECT THERETO AND FOR THE REDEMPTION THEREOF should be deferred until Thursday, the 12th of July.

Assembly agreed.
