QUESTIONS TO MINISTERS

Question No. 11

Mr. Campbell asked the Minister of Natural Resources the following question:

QUESTION: Is Government aware that during September, 1961, the Director of the Marketing Division informed coffee growers in the North West District that Government was arranging for the establishment of a Coffee Board to be run on similar lines to the Rice Marketing Board, and that coffee would be processed in three grades at prices of 45¢, 35¢ and 25¢ per pound in the three grades?

> If so, will the Minister inform the House what arrangements are being made for implementing this Scheme?

The Minister of Natural Resources gave the following reply:

ANSWER: Yes, Sir.

The Ministry has been taking steps to implement the Scheme. In particular, the Ministry has been examining the legislation which has been passed by neighbouring territories, establishing Coffee Boards and it is hoped that draft legislation will shortly be prepared for introduction in this House. Concurrently, the Minister has also been examining proposals for appropriate accommodation for the Coffee Board when it is established, the possibility of the Board undertaking the processing of the coffee beans and most important, the possible sources for providing the finance for the Board.

It should be pointed out that the prices which the Director of Marketing announced are prices which were suggested as being economic ones by the Department of Agriculture at the time. However, the Government would not wish to and could not commit in advance of its establishment, the prices which the Coffee Board would have the power to fix for farmers' coffee. The prices will be related to grades and ruling export prices and the Board will have to fix grades with the approval of the Director of Agriculture. Supplementary questions were asked by Mr. Campbell.

Question No. 15

<u>Mr. Wharton</u> asked the Minister of Labour, Health and Housing the following question:

QUESTION: When will Government place pipe lines along the east side line dam of Lichfield Village, West Coast, Berbice, so that the Health Centre and the Mortuary may be served with pure water?

The Minister of Labour, Health and Housing gave the following reply:

<u>ANSWER:</u> Provision has been made for this work in the 1962 Development Estimates and it will be carried out at an early date.

Question No. 16

Mr. Wharton asked the Minister of Communications the following question:

QUESTION: Is Government aware that several residents in the Trafalgar 29 and 30 Village areas get their letters three to five days after they reach the Fort Wellington Post Office? If so, when does Government propose to have this situation improved?

The Minister of Communications gave the following reply:

ANSWER: There have been a few reports that mails arriving at the Fort Wellington Post Office were not being delivered the same day. This appears to have resulted from the strict control which is being exercised in relation to overtime payments to postal employees.

> The situation at the Fort Wellington Post Office was examined and suitable arrangements have been made to ensure that letters reach their destination not later than the day after their receipt at the Post Office.

Question No. 17

Mr. Blair asked the Minister of Communications the following question:

QUESTION: When will a house to house delivery of mails be introduced between Sisters Post Office and Pln. Mara on the East Bank, Berbice River?

The Minister of Communications gave the following reply:

ANSWER: It is not proposed to introduce a daily house to house delivery of mails in the entire area between Sisters Postal Agency and Mara Settlement on the right bank of the Berbice River. A house to house delivery service has for some time been in operation between Sisters and Lighttown which is 4½ miles away from the Sisters Postal Agency. Mara itself, at the

ANSWER: (Contd.) and a thrice-weekly service has recently been started between Vigilante and Mara. The possibility of starting a thrice-weekly service in the intervening area (i.e. between Lighttown and Vigilante) is under active consideration and it is hoped to make an announcement about this very shortly.

Supplementary questions were asked by Mr. Burnham.

Question No. 18

Mr. Blair asked the Minister of Communications the following question:

- QUESTION: When will the M.V. Lukanani now operating on the Berbice River route be replaced by a boat with more cargo space and better accommodation for passengers?
 - The Minister of Communications gave the following reply:
- ANSWER: The need for improving the Berbice River Steamer service is recognised but because of an acute shortage of ships there is no certainty that this service can be improved within the near future though ways and means of doing so are under constant examination. In any event, however, it should be possible to provide a larger ship for this service when the third new ferry vessel, which is due for completion about the end of the year, is brought into service.

Question No. 19

Mr. Blair asked the Minister of Communications the following question:

- QUESTION: When will a boat with better accommodation for passengers be provided for the Kwakwani and Canje Creek routes?
 - The Minister of Communications gave the following reply:
- ANSWER: The Kwakwani and the Canje Creek areas are served by the same launch which was designed to operate in the peculiar conditions obtaining in the Canje Creek. The heavy growth of Missouri grass in this creek makes it impracticable to use a larger vessel. I am advised that experiments are now in progress to determine whether this grass can be controlled or completely eliminated by the use of modern weedicides. Should these experiments prove successful, the arrangements for transport service will be re-examined.

Supplementary questions were asked by Mr. Blair.

On a motion by Mr. Saffee, Chairman of the Public Accounts Committee, the Assembly adopted the following Resolution:

RESOLVED, That the Report of the Public Accounts Committee of the Legislative Assembly on the Director of Audit's Report on the Accounts of the Transport and Harbours Department for the year ended 31st December, 1960 be referred to the Government for its consideration.

Item 3 - MOTION CONCERNING THE SUSPENSION OF THE CONSTITUTION OF THE ISLAND OF GRENADA.

On a motion by Mr. Bhagwan, Standing Order No. 23(3) was suspended to enable him to move the following motion:

BE IT RESOLVED:

That this Legislative Assembly places on record an expression of its deep concern and profound regret at the action taken by Her Majesty's Government in the suspension of the Constitution of the Island of Grenada.

Mr. Lall seconded the motion but reserved his right to speak at a later stage.

Mr. Campbell, Mr. Bissember and Mr. Cheeks spoke to the motion.

Mr. Burnham moved and Mr. Joaquim seconded the insertion of the following second resolve clause:-

"AND BE IT FURTHER RESOLVED:

That a copy of this Resolution be forwarded to Her Majesty's Principal Secretary of State for the Colonies."

Mr. d'Aguiar spoke.

Mr. Bhagwan accepted Mr. Burnham's amendment.
