ANNOUNCEMENTS BY THE SPEAKER

Reports on Election Petitions

Representation Petition Questioning the Election of Mr. Peter Stanislaus d'Aguiar, Member for Electoral District No. 18 -Georgetown Central.

His Honour the Speaker read and submitted the report on the above petition made by the Honourable Mr. Justice B.O. Adams in compliance with the provisions of section 35(1) of the Legislature (Appointment, Election and Membership Controversies) Ordinance, 1961 (No. 34).

The Honourable Mr. Justice Adams declared on the 20th of December, 1961, that Mr. Peter Stanislaus d'Aguiar was duly elected at the Election held in Electoral District No. 18 - Georgetown Central - on 21st August, 1961.

The Court found that -

- (a) No corrupt practice or illegal practice had been proved to have been committed by or with the knowledge of either candidate at the election.
- (b) Neither candidate at the election had been proved to be guilty by his agent of any corrupt or illegal practice in reference to the election.
- (c) No corrupt practices or illegal practices had, nor was there reason to believe that corrupt practices or illegal practices had extensively prevailed at the election to which the petition related.

Representation Petition Questioning the Election of Mr. Edward Eyre Melville, Member for Electoral District No. 35 - Rupununi.

His Honour the Speaker read and submitted the report on the above petition made by the Honourable Mr. Justice R.S. Miller in compliance with the provisions of section 35(1) of the Legislature (Appointment, Election and Membership Controversies) Ordinance, 1961 (No. 34).

The Honourable Mr. Justice Miller declared on the 29th of January, 1962, that Mr. Edward Eyre Melville was duly elected at the Election held in Electoral District No. 35 - Rupununi - on 21st August, 1961.

The Court found that on consideration of the whole case the petitioner failed in every respect to prove his allegations beyond all doubt and accordingly dismissed the petition.

QUESTIONS TO MINISTERS

Question No. 5.

Mr. Jordan asked the Minister of Communications the following question:

QUESTION:

Is the Honourable Minister aware that although it is reported on Page 15 in the Development Programme 1960/64
Progress Report for the Quarter ended 30th June, 1961, under Post Office, that the external distribution system at Mackenzie for Telephone subscribers' apparatus has been completed, a number of residents in Wismar, Christianburg and North Mackenzie have applied for telephones and have been told that none are available? If the answer is in the affirmative, what steps does the Minister propose to take to make telephones available to these wouldbe subscribers?

The Minister of Communications gave the following reply:

ANSWER:

The Mackenzie Exchange caters for a maximum of 400 subscribers. At present the Exchange is serving 391 subscribers, including 30 in the Wismar-Christianburg area. The subscribers in the Wismar-Christianburg area are connected by means of a 30 pair submarine cable between Mackenzie and Christianburg and it will therefore not be possible immediately to increase the number of subscribers in that area.

There are nine spare exchange numbers which are being reserved for Private Branch Exchange purposes.

The need for the enlargement of the Mackenzie Exchange was foreseen several years ago and an extension scheme was prepared in detail. Owing to lack of funds, however, the project had to be deleted from the Development Estimates in 1959.

In order to meet the pressing demand for more telephones in new areas additional line plant had to be installed in 1961. This additional line plant merely enabled existing spare exchange equipment to be used to provide the additional services required and did not constitute an enlargement of the capacity of the exchange.

Proposals for the expansion of the Mackenzie Exchange are included in the general proposals under consideration for the extension of telecommunications services all over the country.

A BILL intituled AN ORDINANCE TO MAKE PROVISION FOR THE PAYMENT OF REMUNERATION, TRAVELLING AND SUBSISTENCE ALLOWANCES TO MEMBERS OF THE LEGISLATURE, THE SPEAKER OF THE LEGISLATIVE ASSEMBLY AND THE PRESIDENT OF THE SENATE.
