# INTRODUCTION OF BILLS - First Reading

## HIRE-PURCHASE BILL, 1964

(Bill No. 5/1964 (L.A.) published 15.2.64.

A BILL intituled AN ORDINANCE WITH RESPECT TO HIRE-PURCHASE AND SALE UPON CREDIT OF GOODS.

Items 1 and 2 - MOTIONS BY MR. BURNHAM RE (i) ASSISTANCE TO FARMERS WHO SUFFERED LOSS IN THE 1963 FLOODS, AND (ii) THE UNEMPLOYMENT SITUATION.

His Honour the Speaker intimated that Mr. Burnham had requested that consideration of these motions be <u>deferred</u> as he was engaged and unable to attend the sitting.

Assembly agreed.

#### Item 3 - MOTION RE SEVERANCE PAY FOR EMPLOYEES

Mr. Lall moved the following motion:

BE IT RESOLVED:

That this Legislative Assembly accepts the principle of severance pay to be made by employers to their employees as being sound on grounds of social justice and as a medium of social security for workers:

AND BE IT FURTHER RESOLVED:

That this Legislative Assembly recommends to Government the introduction, at an early date, of legislation to give effect to the aforementioned principle for the benefit of all workers in this country.

Mr. Downer seconded the motion, but reserved his right to speak at a later stage.

Mr. Merriman and Mr. Hugh spoke to the motion.

Mr. d'Aguiar moved and Mr. Cheeks seconded the following amendment:

Substitution of a comma for the full stop at the end of the motion, and addition of the following:-

"and that effect should be given to this principle by Government introducing legislation to pay severance pay to all Government employees, classified or unclassified, at the rate of one month's severance pay for every year of service and that this benefit should be extended to all workers."

Mr. Ram Karran spoke.

#### Suspension of Sitting

At 3.56 p.m. the sitting was suspended for tea.

## Resumption of Sitting

At 4.30 p.m. the sitting was resumed.

# Item 4 - MOTION AUTHORISING MINISTER OF FINANCE TO BORROW MONEY FROM BANK

In terms of Standing Order No. 21, the Attorney General laid over the Governor's rec mmendation and moved the following motion:

#### BE IT RESOLVED:

That this Legislative Assembly in terms of section 16 of the Financial Administration and Audit Ordinance, 1961 (No. 39) as amended by Ordinance No. 23 of 1963 authorises the Minister of Finance to borrow in whole or in part, by means of advances from the Bank, or by the issue of Treasury Bills, an amount not exceeding six million dollar to meet current requirements from time to time.

# AND BE IT FURTHER RESOLVED:

That the above amount of six million dollars shall be in substitution for the amounts totalling seven million dollars authorised in Resolution No. XIX and LVI of the First Session.

Mr. Jordan and Mr. d'Aguiar spoke to the motion. Thereafter, the Attorney General replied.

The motion was then put and carried.
