QUESTIONS TO MINISTERS

Question No. 37

<u>Mr. Wharton</u> asked the Minister of Labour, Health and Housing the following question:

<u>Question:</u> (a) When will Government provide running water for the mortuary at Lichfield, West Coast, Berbice?

> (b) Is Government aware that the mortuary attendant has to fetch water from a distance of half a mile whenever there is a post mortem?

The <u>Minister of Labour</u>, <u>Health and Housing</u> gave the following reply:

<u>Answer:</u> Government has already installed a 400 gallon rain water tank at the mortuary. The expenditure which would have to be incurred to extend pipelines to the mortuary cannot be justified in the light of the infrequent use of the mortuary and the small quantities of water required.

Question No. 38

<u>Mr. Blair</u> asked the Minister of Agriculture, Forests and Lands the following question:

Question: Is it true that Government has decided not to rebuild the school at Providence, East Bank, Berbice River, contrary to Resolution No. XLVIII of 2nd August, 1962?

The <u>Minister of Agriculture</u>, Forests and Lands gave the following reply:

Answer: No. Messrs. Bookers Sugar Estates Ltd. have agreed to lease to Government the old school site plus three additional acres of land, and it is planned to start construction of a new Rural Type school for 400 children later in the year.

Item 1 - MOTION FOR APPROVAL OF GOVERNMENT WHARVES (CHARGES) RULES, 1964

On a motion by the Minister of Communications, the Assembly adopted the following Resolution:

RESOLVED, That the Legislature in terms of section 4 of the Government Wharves Ordinance, Chapter 263, approves of the Government Wharves (Charges) Rules, 1964 which were made by the Governor on the 18th of March, 1964.

Item 2 - STATUTORY PUBLICATIONS BILL, 1964 - Bill No. 7/1964 (L.A.)

On a motion by the Attorney-General, the BILL intituled AN ORDINANCE TO REGULATE THE PUBLICATION OF CERTAIN INSTRUMENTS IN NEWSPAPERS was read a second time and was thereafter taken through its remaining stages and passed as **pr**inted.

Item 3 - PUBLIC CORPORATIONS (AMENDMENT) BILL, 1964 -Bill No. 8/1964 (L.A.)

On a motion by the Attorney-General, the BILL intituled AN ORDINANCE TO AMEND THE PUBLIC CORPORATIONS ORDINANCE was read a second time and was thereafter taken through its remaining stages and passed as printed.

<u>Item 4</u> - <u>GEORGETOWN CULTURAL CENTRE AMENDMENT BILL 1964</u> -<u>Bil No. 4</u> 4 S

On a motion by the Minister of Agriculture, Forests and Lands, the BILL intituled AN ORDINANCE TO AMEND THE GEORGETOWN CULTURAL CENTRE ORDINANCE was read a second time and was thereafter taken through its remaining stages and passed as printed.

Item 5 - CUSTOMS (AMENDMENT) BILL, 1964 - Bill No. 9/1964 (L.A.)

On a motion by the Minister of Finance, the BILL intituled AN ORDINANCE TO AMEND THE CUSTOMS ORDINANCE was read a second time and was thereafter taken through its remaining stages and passed as printed. Item 6 - CASE PENSION BILL, 1964 - Bill No. 12/1964 (L.A.)

In terms of Standing Order No. 21, the Minister of Finance laid over the Governor's recommendation.

On a motion by the Minister of Finance, the BILL intituled AN ORDINANCE TO MAKE SPECIAL PROVISION WITH RESPECT TO THE PENSIONABLE SERVICE OF FREDERICK WALTER ELEAZER CASE was read a second time.

Assembly then resolved itself into Committee to consider the bill Clause by Clause.

In Committee

<u>Clause 1</u> - A motion by Mr. Burnham for the substitution of the name "Rodway" for the name "Case" was <u>negatived</u>. Clause 1 was then passed as printed.

Clause 2'- was passed as printed.

<u>Clause 3</u> - A motion by Mr. Burnham for the substitution of the name "James Alwyn Rodway" for the name "Frederick Walter Eleazar Case" was <u>negatived</u>. Clause 3 was then passed as printed.

Assembly resumed.

On a motion by the Minister of Finance, the BILL intituled AN ORDINANCE TO MAKE SPECIAL PROVISION WITH RESPECT TO THE PENSIONABLE SERVICE OF FREDERICK WALTER ELEAZAR CASE was read the third time and passed as printed.

Item 7 - WIDOWS AND ORPHANS PENSION (AMENDMENT) BILL 1964 B1 No. 13/1964 (L.A.

On a motion by the Minister of Finance, the BILL intituled AN ORDINANCE TO AMEND THE WIDOWS AND ORPHANS PENSION ORDINANCE BY MAKING PROVISION FOR THE INCREASE OF PENSIONS REGISTERED ON THE 31ST DECEMBER, 1958, OF PENSIONS REGISTERED SUBSEQUENT TO THE 31ST DECEMBER, 1958, IN RESPECT OF MARRIED OFFICERS WHO ON THAT DATE WERE AWAITING MEDICAL EXAMINATION, AND OF PENSIONS IN PAYMENT ON THAT DATE. was read a second time and was thereafter taken through its remaining stages and passed as printed.

Item 8 - LI UOR LICENSING AMENDMENT) BILL, 1964 -Bill No. 14/1964 (L.A.)

On a motion by the Minister of Finance, the BILL intituled AN ORDINANCE TO AMEND THE LIQUOR LICENSING ORDINANCE was read a second time and was thereafter taken through its remaining stages and passed as printed.

Item 9 - IEGAL PRACTITIONERS (AMENDMENT) BILL, 1964 -Bill No. 15/1964 (L.A.)

At the request of the Attorney-General, consideration of this Bill was <u>deferred</u>.

DISTURBANCES IN BRITISH GUIANA

Before the adjournment, His Honour the Speaker referred to the present disturbances in the Colony and, on his invitation, the leaders of the three Political Parties in the Assembly were also allowed to refer to the situation.

Dr. Jagan, Mr. Burnham and Mr. Cheeks (in the absence of Mr. d'Aguiar) spoke.

Aftera further appeal was made by His Honour, the representatives of the three Parties agreed to appeal to the people of the country to cease those senseless actions and the Premier intimated that Members of the Assembly would be asked to meet informally to discuss further the situation with a view to bringing an end to the disturbances and also achieving a consensus.

ADJOURNMENT

At 4.23 p.m. on a motion by the Minister of Agriculture, Forests and Lands, the Assembly was adjourned to 2.00 p.m. on Tuesday, the 2nd of June, 1964.
