Mr. Downer asked the Minister of Finance the following question:

- Question:

 (i) Will the Honourable the Minister of Finance state whether the Jacobs Report was published today (27th January) before it was laid in the Legislative Assemb y?
 - (ii) Will the Minister state:
 - (a) the medium through which this earlier publication was effected?
 - (b) if there has been any breach of the normal procedure by which such documents are released to the public?
 - (iii) If the answer to (ii)(b) is in the affirmative,
 will the Minister state:
 - (a) what office or department of the Government was responsible for this breach?
 - (b) what action the Government proposes to take with espect to this breach by having the Jacobs Report made public before it was laid in the House?

The Minister of Finance gave the following reply:

Answer: (i) Yes.

- (ii) (a) Bookers Stores Limited, the agents in British Guiana of Her Majesty's Stationery Office, London.
 - (b) "Normal procedure" can only be determined by reference to the practice with respect to the publication of other reports in the past:

Waddington and Robertson Reports

Publication times in London were arranged to coincide with announcements by the Governor in the Legislative Council.

Wynn-Parry Riot Report

Iaid in Legislative Assembly on October 3, 1962, at approximately 2.10 p.m., but published at 9.45 a.m. (4 hours and 25 minutes earlier) on the same day.

K.C. Jacobs Report

Iaid in Legislative Assembly on January 27, 1964, at about .10 p.m., but published on January 26, 1964, at 8.16 p.m., some 17 hours 54 minutes earlier.

Because of the unusually long interval - 17 hours 54 minutes - between publication of the Jacobs Report and its tabling in the Legislative Assembly, as compared with that in respect of the Wynn-Parry Report (4 hours 25 minutes), there was some departure from the "normal procedure" in this instance.

- (iii) (a) The Office of the Governor.
 - (b) The Government has already drawn the Governor's attention to this matter and has observed that the manner in which the Report was published locally, which enabled the information media to have it long before it was seen by Honourable Members of the Hous, was a discourtesy to the Legislature.
