#### QUESTIONS TO MINISTERS

#### QUESTION No. 21

Mr. Robertson asked t e Minister of Agriculture, Forests and Lands the following question:

Question: Will the Minister of Agriculture, Forests and Lands state -

(a) How much land has benefited as a result of the Boerasirie Extension Drainage and Irrigation Scheme?

- (b) (i) When was the Drainage and Irrigation Scheme commenced, and
  - (ii) at what cost was it carried out?
- (c) How much of his land is
  - (i) privatel owned,
  - (ii) under sugar, and
  - (iii) under other crops?
- (d) How much of the land is Crown land?
- (e) How much of the Crown land has been beneficially occupied since the completion of the Scheme?
- (f) Whether soil surveys were carried out on the Crown lands before the works were commenc d?

The Minister of Agriculture, Forests and Lands gave the following reply:

- Answer: (a) 112,689 acres. 49,175 acres of new lands have become cultivable and the irrigation of 63,514 acres served by the old conservancies has improved.
  - (b) (i) 1952 (ii) \$12,042,000.
  - (c) (i) 74,354 acres, (ii) Nil (iii) 250 acres.
  - (d) 39,736 acres
  - (e) This information is not available. It has not been possible to carry out inspections of this area, but 3,394 acres of Crown land have been distributed to farmers.
  - (f) No soil surveys were carried out prior to the commencement of the Scheme in 1952.

Supplementary question were asked by Mr. Burnham, Mr. d'Aguiar and Mr. Bhagwan.
