IN COMMITTEE

Clauses 2 and 3

Mr. Everall Franklin, M.P., moved the following amendments which were <u>put</u> and <u>carried</u>:

Paragraph 3(1)

156A(1)

Immediately after the word 'shall' (line five) delete the rest of sentence and add the following words "present to the Speaker a petition to recall that Member signed by not less than two thirds of the persons on the list from which its' Members were extracted, supporting the recall of the member"

And

Paragraph 3 (2)

156A(1)

Delete the entire paragraph and replace with the following:

"The speaker being satisfied that the petition stated in 156A(1) is in order, shall notify the Member concerned of the notice of recall and declare the Member's seat vacant and the vacant seat be filled in the manner provided by law"

Clauses 2 and 3 were then passed as amended.

On a motion by the Minister of Home Affairs the Constitution (Amendment) Bill 2007 - Bill No. 17/2007 was read a third time and <u>passed</u> as <u>amended</u>.

<u>ITEM 2</u> - <u>APPOINTMENT OF MEMBERS TO THE ETHNIC RELATIONS COMMISSION</u>

The Minister of Health moved the following motion:

WHEREAS the Parliamentary Committee of Appointments provided for in Article 119C of the constitution and established in the 9th Parliament on December 21, 2006 has been meeting regularly and has tabled three Reports, one Special Report and 4 motions to the National Assembly;

AND WHEREAS the Committee of Appointments tabled a Motion proposing a list of 162 entities to consult with a new consensual mechanism for such consultations in relation to the Ethnic Relations Commission which had been unanimously supported by the said Committee;

AND WHEREAS this Motion on May 10, 2007 failed to achieve the support of two-thirds of the House as required by the constitution;

AND WHEREAS the Committee has since tried inclusive of its August 7th meeting to resolve the issue with a view to returning the matter for the attention of the House before the recess;

AND WHEREAS consensus on the way forward has not been obtained and the issues preventing the reconstitution of the ERC may remain unresolved for an extended period of time;

AND WHEREAS the term of office of the current Ethnic Relations Commissioners will come to an end in August 2007 while the Commission under Article 212A will continue to exist;

BE IT RESOLVED:

That the National Assembly takes note of this serious development;

AND BE IT RESOLVED:

That the House so informs the President of the Republic;

AND BE IT FURTHER RESOLVED:

That this National Assembly calls on the President to take such steps so as to enable the Ethnic Relations Commission to continue to carry out its constitutional responsibilities in the interim.
