Could the Hon. Prime Minister state:

What rights, privileges, and entitlements do first ladies and former first ladies enjoy by practice or convention?

(Notice Paper No. 214 (Q153 Opp150) published on 2008-02-01)

#### **Answer**

There are no statutes pronouncing on rights, privileges and entitlements of First Ladies save and except those protected by law as a wife.

A Former First Lady whose spouse serves as the Executive President is not entitled to any rights, privileges and entitlements save and except those provided by a competent Court of Law secondary to claims arising from the implied separation and/or divorce.

A Former First Lady of a Former President who is alive is a private citizen. A Former First Lady of a deceased Former President is entitled to survivor's benefits that are based on her spouse's pension.

#### 2. CLEARING OF EAST COAST DEMERARA BACK LANDS

Member Asking:

Mrs. Sheila Holder, M.P.

**Minister Answering:** 

The Minister of Agriculture

- (i) When will the Antilope grass field aback of Lusignan Pasture be moved down as requested by the residents and survivors of January 26 slaughter of innocent men, women and children?
- (ii) Given that the East Coast Demerara back lands up to the Mahaica river is on average seven (7) miles deep, how many miles is proposed to be cleared in the current land clearing exercise and over what period?
- (iii) Through what process were persons and enterprises contracted to clear/bulldoze the East Coast Demerara back lands?

#### **Answers**

- (i) Discussions have started with the Cattle farmers' group, which manages the pasture, on the residents' observations. Already, a decision has been taken to establish a Policing Group outpost on a section of the Lusignan pasture.
- (ii) The backlands clearing activity may only span from Enmore to Beterverwagting. The Joint Services require a clear line of sight of about 1000 metres from the residential area going South. The duration of this aspect of Operation Restore Order depends on a number of factors including weather condition and the availability of more land-clearing equipment.
- (iii) Members of the Joint Services are executing the clearing of the backland activities.

#### 3. REDUCTION OF SPEED LIMIT - AMELIA'S WARD

Could the Honourable Minister of Home Affairs tell this National Assembly whether he is prepared to amend the necessary regulations to reduce the speed limit from 60 mph. to 30 mph., for Amelia's Ward, between Millie's Hideout and the Kara Kara Bridge, in Region # 10, given that this area is now well populated?

#### Answer

The Honourable Minister wishes to inform the National Assembly that the area under focus was visited by the Traffic Officer and an assessment done. Currently the speed limit to Linden is 60 mph unto the Kara Kara Bridge.

Having considered all the issues concerned, including housing development, the Police Administration has recommended that the speed limit on the Soesdyke Linden Highway between the Millie's Hideout area to Kara Kara Bridge be reduced to 30 mph.

#### 4. <u>MEMBERS OF THE SPECIAL CONSTABULARY OF THE GUYANA POLICE</u> FORCE

Why, given that Section 78(1) of the Police Act provides that "Every member of the Special Constabulary, when called out for full time service..., shall be paid for his services as may be provided for by Parliament, at the same rate as a member of the Force of equivalent rank".

- (i) Some members of the Special Constabulary are not in receipt of their monies from the President's Annual Award?
- (ii) Some members of the Special Constabulary are not paid commuted overtime?

#### **Answers**

The Honourable Minister wishes to inform the National Assembly that there are two (2) categories of Special Constables:

- 1. Regular Specials, who are paid from Government Funds; and
- A Self-Funding Section (Guystac) who are paid by funds earned from various agencies and corporations who hire their services. Hence the difficulty.

The money paid by these Agencies/Corporations is inadequate. This is complemented by often loss of revenue due to absenteeism, and larceny from places of employment. These are the main reasons for the shortage of funds to pay the one month bonus to these ranks.

## 5. AVAILABILITY OF PATROL BOATS IN THE 'D' DIVISION OF THE GUYANA POLICE FORCE

Would the Honourable Minister of Home Affair tell this National Assembly whether 'D' Division of the Guyana Police Force has any patrol boats available to it to service its two sub-divisions?

If yes, can the Honourable Minister inform this National Assembly:

- (a) Whether this/these boat/boats is/are available on a 24 hour basis?
- (b) Whether the Guyana Police Force has adequate human resources to man this/these boat/boats?

- (c) Where is/are this/these boat/boats moored when not in active use?
- (d) Is the Honourable Minister satisfied with the operational capacity of the Guyana Police Force to patrol the Demerara and Essequibo rivers?

If no, could the Honourable Minister inform this National Assembly:

- (a) Why 'D' Division of the Guyana Police Force is without any patrol boats to enable them to carry out their statutory duties in the Demerara and Essequibo rivers?
- (b) When will 'D' Division of the Guyana Police Force receive patrol boats for its Division?

#### **Answers**

The Honourable Minister wishes to inform the National Assembly that there are three (3) boats available to service the two sub-divisions.

- (a) They are available on a 24 hour basis.
- (b) The human resources are adequate at this time.
- (c) The boats are moored in the Demerara and Essequibo Rivers.
- (d) The current operational capacity of the boats of the Force covers the Demerara River between Timehri to Georgetown.

The Essequibo River poses severe challenges for the Force. However, the Police have a boat at Charity and a boat at Wakenaam. They are supported by two (2) Community Policing Group boats. A boat is currently being made available for the Police in 'G' Division in the Essequibo River.

Patrols are also done by one boat based at Bartica and supported by one Community Policing Group boat. In direct response to the question of satisfaction, one can hardly be satisfied with its level of services until it can provide a boat service in all riverain communities.

The current services are inadequate to provide effective patrols, investigations and to deal with issues in the Essequibo River.

The Honourable Minister wishes to inform the National Assembly that:

- (i) No mandatory drug testing programme exists within the Guyana Police Force and the Guyana Prison Service;
- (ii) The Police Act does not provide for drug testing:
- (iii) The Administration of the Guyana Prison Service has never found the prevalence of drug use among its ranks as an issue of concern to the Department and thus never advocated that a special dispensation of acquiring/establishing a drug testing programme for ranks to be introduced.
- (iv) However, the Prison Department is not averse to the implementation of such a programme, since it will allow for the screening of staff in an effort to determine whether they are under the influence of any narcotic drug, while discharging their statutory responsibilities.

That a Special Select Committee be established to enquire into and to investigate the services being provided by the Guyana Power and Light Co. and to make recommendations for its improvement;

#### BE IT FURTHER RESOLVED:

That the Special Select Committee be permitted to received evidence from Members of the public and organizations, including consumers, the Public Utilities

Commission, Consumer Associations, the Private Sector and civil society organizations working with affected groups;

#### BE IT FURTHER RESOLVED:

That the Special Select Committee report to this National Assembly within three months and the National Assembly communicates the findings and recommendations to the Guyana Power and Light Co. for their adoption.

#### ITEM 2 - THE ESTABLISHMENT OF A LAW REFORM COMMISSION

Mrs. Deborah Backer, M.P., moved the following motion:

WHEREAS the British Guiana Legislature enacted hundreds of Acts of Parliament and subsidiary legislation many of which remain in force more than 100 years after there enactment;

AND WHEREAS, since Guyana attained its independence on the 26<sup>th</sup> day of May, 1966, the Parliament of Guyana also enacted hundreds of Acts of Parliament and subsidiary legislation;

AND WHEREAS an ongoing and systematic review of all of these Acts of Parliament, together with their subsidiary legislation, is required to ensure that they are updated, amended and, where necessary, repealed;

AND WHEREAS it is desirable to have an ongoing and continuing process for the review, updating and modernization of the laws of Guyana, including the enactment of new legislation, which respond to and reflect the present and future needs and aspiration of the people of Guyana;

AND WHEREAS it is accepted, in many Commonwealth and non-Commonwealth countries, that the most efficient and institutional mechanism to systematically review and modernize the laws of their respective countries and plan for future legislation is a permanent Law Reform Commission;

AND WHEREAS many Commonwealth and non-Commonwealth countries have established permanent Law Reform Commissions,

#### BE IT RESOLVED:

That this National Assembly urges the Government to establish an independent permanent Law Reform Commission with the mandate, which shall include, but not be limited to, the following:

- 1. To keep under continuous review, all of the Laws of Guyana, with the view to their systematic development and reform, including: the modification of any branch of the law; the elimination of anomalies; the repeal of obsolete and unnecessary enactments; the reduction of the number of separate enactments; and generally, the modernization of the law;
- To receive and consider suggestions for the reform of the law which may be forwarded to it by Ministers of the Government; public officials; associations of lawyers and members of the public;
- To obtain such information, in regard to the laws and legal systems of other countries, as in the opinion of the Commission, is likely to facilitate the effective performance of any of its functions;
- 4. To make recommendations to the Ministry of Legal Affairs for the modification, repeal and generally, for the modernization of the Law of Guyana.

WHEREAS the Fiscal Management and Accountability Act was assented to by His Excellency the President of Guyana on the 16<sup>th</sup> December, 2003;

AND WHEREAS the said Act is intended, *inter alia*, to improve accountability in fiscal management;

AND WHEREAS Section 81 of the said Act makes provision for the forgiveness, postponement or reduction of debts by the Minister of Finance;

AND WHEREAS Section 81(3) of the said Act provides that the National Assembly may set a limit on the aggregate amount of debt obligations that may be forgiven, postponed or reduced by the Minister of Finance without the approval of the National Assembly in any fiscal year;

#### BE IT RESOLVED:

That this National Assembly hereby sets a limit of \$10 million (ten million dollars) as the aggregate amount of debt obligations that may be forgiven, postponed or reduced without the approval of the National Assembly;

#### BE IT FURTHER RESOLVED:

That this limit takes effect from fiscal year 2007.
