Answer:

The Member asking this question is not precise as to which bridge leading into Karasabai he wants repaired. There are three (3) bridges (Jawari Creek Bridge, S. Creek Bridge and Yurora Creek Bridge) situated between Meeterzero and Karasabai along the Morero Mountain pass. Further, I am not aware of any of these structures being in a state of disrepair.

I am however, aware of an existing problem with the approaches at the Yurora bridge across the Yurora River. Latest information is that the structure is intact. Due to heavy and continuous rainfall in that part of Region 9 erosion has taken place. The Regional Administration and the Ministry of Local Government and Regional Development are aware of this situation and as recent as Friday 14th November, 2008, Coordinator of Hinterland Affairs within the Ministry, former Minister of Local Government and Regional Development, Mr. Harripersaud Nokta, M.P., and the Regional Chairman of Region 9, Mr. Clarindo Lucas, visited this bridge and made an on-the-spot assessment of the erosion. Temporary measures have since been put in place to facilitate crossing on the bridge.

Subsequently, the Regional Engineer visited the site and has submitted a design and costing to effect repairs. The Office of the Prime Minister has been requested to assist under the hinterland road programme. Alternatively, Ministry of Local Government will seek funding under the 2009 budget.

I must mention that heavy rains in the North and South Pakarimas during the first half of 2008 have caused damaged to sections of the roadway, up the mountains and even the flat areas. It is hoped that in early of 2009 monies will be made available to rehabilitate the affected sections.
