1. How many requests have been made annually to the General Registrar's Office for birth certificates over the last three years respectively and how many have been issued per region? 2. In view of the constant complaints of Indigenous communities about difficulties being experienced in acquiring birth certificates and consequently denial of their right to be registered as an elector, what arrangements is the Honourable Minister prepared to put in place to allow them to (a) acquire birth certificates and (b) be registered as an elector?

Answers

1. The Honourable Minister wishes to inform the National Assembly that for the last three years, 2006, 2007 and 2008 the following applications were received and birth certificates issued:

Year	Applications Received	Birth Certificate Issued
2006	79,286	198,000
2007	69,419	208,000
2008	109,449	254,000

Record keeping at the General Registrar's Office was not done by regions for the requested years but has since been implemented from September, 2009.

- 2. (i) The General Registrar's Office made visits to regions 1, 7, 8, 9, parts of 2 & 10 to educate villagers on the importance of Birth Registration and the acquisition of Birth Certificates.
 - (ii) Training of Community Development Officers in the said regions on the requirements of Late Registration to ensure the birth registration of adults.
 - (iii) Appointing and training of Community Health Workers in Birth Registration to ensure all children are registered at birth.

- (iv) Community Development Officers in each region, where the Postal Service is not available, ensure applications are brought out and Certificates taken in.
- (v) Where Postal Services are available applications are accepted and sent to the General Registrar's Office, certificates are issued and returned by this service.
- (vi) Church leaders and Health workers are also very active in these regions in assisting with Late Registrations and ensuring applications are brought out and Certificates taken back.
- (vii) The General Registrar's Office will continue to engage the Ministry of Amerindian Affairs to ensure Birth Certificates are available to the region aforementioned.
- (viii) The General Registrar's Office conscious of the importance of having residents registered and in possession of Birth Certificates has dedicated a section to the Late Registration of residents in regions 1, 7, 8 and 9.

The General Registrar's Office with the assistance of the Community Development Officers, Community Health Workers, Ministry of Amerindian Affairs and Church Leaders will continue to offer Regions 1, 7, 8 and 9 this service.

"Re-number as clause 4(1)

Insert the following as Clause 4(2) -

"(2) Notwithstanding any other provision of this Act a licence shall not be approved, issued, cancelled, revoked or suspended without the prior express written approval of the Minister who shall be the Licensing Authority under this Act.""

Clause 4 was then passed as amended.

Clause 5 was passed as printed.

Clause 6

The Minister of Home Affairs moved the following amendment which was <u>put</u> and <u>carried</u>: Clause 6(2):

"For the words "body or association of persons" substitute the word "company".

Clause 6 was then passed as amended.

Clauses 7 to 24 were passed as printed.

The Schedule

The Minister of Home Affairs moved the following amendment which was <u>put</u> and <u>carried</u>:

Section B, paragraph 10:

"Delete the word "or the head of the incorporated association".

The Schedule was then passed as amended.
