ITEM 6 - NON-LETHAL WEAPONS

Mr. Everall Franklin, M.P. moved the following motion:

WHEREAS the Members of the Guyana Police Force are equipped with weapons such as firearms in the form of handguns, shotguns, rifles and machine guns as well as batons;

AND WHEREAS in the execution of their duties they may have to use force to protect themselves, prevent the commission of a crime or protect property;

AND WHEREAS these weapons, in particular firearms, without exception are designed to inflict severe injury to a person or persons:

AND WHEREAS these injuries may often result in the unwanted death of the targeted person or persons due to the very nature of the weapon's design;

AND WHEREAS without the required training, capability, marksmanship and judgment of the user severe injury or death may be the result of such use;

AND WHEREAS the Members of the Guyana Police Force in executing their duty often have no alternative but to use the issued weapons and from time to time bemoan the fact that nonlethal weapons could have been used if available,

BE IT RESOLVED:

- (i) That hand to hand combat training be intensified and expanded within the Guyana Police Force;
- (ii) That a psychological evaluation of all ranks carrying firearms be conducted annually;
- (iii) That counseling be made mandatory for ranks who have used force resulting in death;
- (iv) That the Guyana Police Force design and conduct within six (6) months marksmanship training for all ranks authorized to use firearms; and
- (v) That non-lethal weapons such as pepper spray, tasers and non and less lethal ammunition such as rubber projectiles be acquired and police ranks trained in their use.

The Minister of Home Affairs moved the following amendments, which were <u>put</u> and <u>carried</u>: "In the 4th AND WHEREAS clause delete the phrase 'due to the very nature of the weapon's design';

In the 6th AND WHEREAS clause delete the entire paragraph and replace with a new clause which will now read:

'AND WHEREAS the use of legitimate and appropriate force is the basis of all law enforcement agencies globally;

AND WHEREAS that the Guyana Police Force in recent years have been challenged by heavily armed and equipped criminals using high powered rapid fire weapons such as AK47s, and hand grenades;'

Insert a new BE IT RESOLVED clause which will read as follows:

'That this National Assembly recognizes the right of the Guyana Police Force to use legitimate force within which the use of non-lethal weapons is an integral component of the standard operational procedures and that in certain recent incidences the police have had little choices but to respond appropriately to protect their ranks and citizens;'

That Clause 1 of the original motion will become Clause 2.

Clauses 2 and 3 of the original motion be deleted and replaced by the following clause:

'3. That the Guyana Police Force reviews its training programmes and assessments of ranks before issuing them with firearms taking into account the need for counceling and psychological programmes;'

Delete Clause 4 of the original motion and insert the following:

'4. That the Guyana Police Force intensifies its training programme in marksmanship for all ranks authorized to use firearms;'

Delete Clause 5 of the original motion and replace it with the following:

'5. That the use of non-lethal weapons such as pepper spray, water cannons, and non and less lethal ammunition, such as rubber projectiles, be extended and training intensified.'"

The motion as amended was then <u>put</u> and <u>carried</u>.
