2. NOISE NUISANCE, DUST NUISANCE AND DEGRADATION TO RESIDENTS OF GANGES STREET, PRASHAD NAGAR

*From 1997 to September 29, 2009 (13 years) there were several exchanges of correspondence, on behalf of residents of Ganges Street, Prashad Nagar on the one hand and the Guyana Power and Light Inc., (GPL) and the Environmental Protection Agency on the other complaining about the noise nuisance, dust nuisance and degradation of their community's scenic environment. A petition dated September 29, 2009 from Ganges Street residents stipulating the noise/dust/smoke nuisance and health hazards was sent to the Prime Minister, the Director of the Environmental Protection Agency, the Chairman of GPL, the Mayor of the Georgetown City Council and the Chairman of the Central Housing and Planning Authority. To date all promises made to these residents by GPL have not been fulfilled. Will the honourable Prime Minister indicate to the residents of Ganges Street who have complained about these environmental nuisances and health hazards whether their quest for mitigation measures will ever be forthcoming and if so, when and how?
